Special Public Safety Committee Meeting Minutes

Wednesday, March 1, 2023

The Public Safety Committee met on March 1, 2023 via Zoom Audio and Video Conference. The Public Safety discussed the following information:

- **Discussion on Liquor License Applications**

The Public Safety Committee met with representatives from Barn Yard Barbeque located at 582 East Fordham Road. The Public Safety Committee expressed concerns regarding the type of license the applicant was applying for because the establishment is known to host events rather than operating as a restaurant. They were also concerned about the underage drinking that has been reported inside of this establishment, however, the business owner never received a violation. After further discussion and clarification, the Public Safety Committee will be recommending the renewal of this liquor license application to the New York State Liquor Authority with stipulations that most of the income at the establishment is from the sale of food and beverages. The Public Safety Committee also met with the representatives from La Cantina Mex Bar and Lounge located at 2467 Arthur Avenue. This establishment has multiple noise complaints. The business owner reported that there are a group of loud individuals who often socialize in front of the establishment. The business owners has seek assistance for this matter from the local precinct and has failed to receive assistance. The Public Safety Committee will be recommending the renewal of this liquor license application to the New York State Liquor Authority with stipulations that the business owner hires security for the weekends to assist with the gathering in front of the establishments to prevent any further noise complaints.
