1. A motion to issue a letter of support to the New York City Department of City Planning in support of their City of Yes for Carbon Neutrality (COYCN) Zoning Text Amendment ULURP Number: N230113ZRY.
2. A motion to support the 48th Precinct Community Council's National Night Out's funding proposal request.
3. A motion to support the River Garden's Story Time (Option 3) funding proposal request.
4. A motion to issue a letter to the New York State elected officials representing Drew Gardens requesting that the New York State Department of Transportation reopen the garden as soon as possible.
