Public Safety Committee Meeting Minutes

The Public Safety Committee met on May 17, 2023 via Zoom Audio and Video Conference. The Public Safety Committee discussed the following information:

- **Discussion on Liquor License Applications**

The Public Safety Committee discussed and reviewed the following liquor license applications:

- Cakor Restaurant located at 632 East 186th Street (Renewal Application) – The multitude of NYC311 complaints that are filed at this location was a concern for the Public Safety Committee, however, the owner informed us that the Police Department has not enquired or issued any violations about the complaints. They were also informed that there is another business in close proximity to Cakor Restaurant that plays loud music that could explain the complaints and the lack of enforcement. The Public Safety Committee will be issuing a favorable recommendation will be issued to the New York State Liquor Authority with the intent to limit alcohol serving hours.
- El Lider Restaurant Corp. located at 4535 Park Avenue (Renewal Application) – The Public Safety Committee will issue a favorable recommendation to the New York State Liquor Authority.
- Sazon and Sabores Restaurant located at 485 East 180th Street (New Application and Temporary Retail Permit) – The new administration of the Sazon and Sabores Restaurant was advised by the Public Safety Committee to monitor the noise complaints that were historically at this location. Ultimately, Public Safety Committee will issue a favorable recommendation to the New York State Liquor Authority.
- Briska Grocery located at 2333 Arthur Avenue (Renewal Application) – The Public Safety Committee will issue a favorable recommendation to the New York State Liquor Authority.
- Billar El Nuevo Ambiente located at 408 East Tremont Avenue (Renewal Application) – The Public Safety Committee will issue a favorable recommendation to the New York State Liquor Authority.
- Bar and Restaurant El Salvadoreno located at 451 Morris Park Avenue (Renewal Application) – The Public Safety Committee will issue a favorable recommendation will be issued to the New York State Liquor Authority.

- MME Banquet Hall located at 861 East 180th Street (New Application) – The Public Safety Committee will issue a favorable recommendation to the New York State Liquor Authority.
- **Review of the 48th Precinct Community Council’s Funding Proposal**

The Public Safety Committee reviewed 48th Precinct Community Council’s funding proposal for the rental fee of a bouncy house for the 48th Precinct’s National Night Out event. The Public Safety Committee recommends that this funding proposal be funded.
