**Public Safety Committee Meeting Minutes**

Wednesday, October 25, 2023

The Public Safety Committee met on October 25, 2023 via Zoom Audio and Video Conference and in-person at the district office. The Public Safety Committee discussed the following information:

- **Discussion on Liquor License Applications**

The Public Safety Committee reviewed the liquor license applications for the following establishments: Zhong Zhong Noodles located at 657 East 189<sup>th</sup> Street, J&G Italian Restaurant located at 2329 Arthur Avenue, Bronx Beer Hall located at 2344 Arthur Avenue, and Emilia's Restaurant located at 2331 Arthur Avenue. After discussing and reviewing the applications and NYC311 complaints, the Public Safety Committee will issue a favorable recommendation to the New York State Liquor Authority for these establishments. The Public Safety Committee also reviewed the liquor license application for El Nuevo Valle #2 Restaurant located at 855 East 180<sup>th</sup> Street. After discussing and reviewing this application and NYC311 complaints, the Public Safety Committee will issue a recommendation with stipulations to the New York State Liquor Authority. The recommendation is contingent on the request for information that will be sent New York City Department of Health and Mental Hygiene concerning the findings of previous complaints or violations, if any exist.

- **Discussion on the Preliminary Community District Needs and Community Board Budget Requests for Fiscal Year 2025**

The Public Safety Committee discussed the Preliminary Community District Needs and Community Board Budget Requests for Fiscal Year 2025. The Public Safety Committee added a request to fund technology to support the New York City Police Department's capacity to combat cybercrime, and a request for funds to purchase a tow truck for the 48<sup>th</sup> Precinct.
