Public Safety Committee Meeting Minutes

The Public Safety Committee met on November 22, 2023 via Zoom Audio and Video Conference and in-person at the district office. The following Board Members were present at the meeting: Nicole Carter, Frank Franz, Jessii Parham, Carmen Rivera, Kristine Rivera.

The Public Safety Committee discussed the following information:

- **Discussion on the Adult-Use Retail Dispensary License Application for 2375 Arthur Avenue**

The Public Safety Committee reviewed and discussed the Adult-Use Retail Dispensary License Application for 2375 Arthur Avenue. The Public Safety Committee advised the applicant to ensure that smoking outside of the business is prohibited and that under age customers are not allowed inside the establishment. After reviewing and discussing the application, the Public Safety Committee will not issue a recommendation and will instead explain the proximity concerns with the other applicants to the New York Office of Cannabis Management.

- **Discussion on the All Night Permit Notice for Roy's Restaurant located at 880 East Tremont Avenue**

The Public Safety Committee discussed the All Night Permit Notice for Roy's Restaurant located at 880 East Tremont Avenue. The Public Safety Committee was informed by the business owner that they will doubling their security personnel on that evening. After reviewing and discussing this notice, the Public Safety Committee will issue a favorable recommendation to the New York City Police Department and New York State Liquor Authority.

- **Discussion on the FOIL Request for the New York City Department of Youth and Community Development**

The Public Safety Committee was informed by District Manager Rafael Moure-Punnett that a FOIL request was submitted to the New York City Department of Youth and Community Development on behalf of the Community Board. The FOIL request requested the New York City's contract held by Release the Grip, through the conduit of Bronx Connect, for Cure Violence programming in the 48th Police Precinct. The Community Board also requested the New York City Department of Youth and Community Development and/or Mayor's Office Release the Grip's contract performance, including deliverables and percentage of deliverables accomplished for each review period. This request was submitted to ensure that the program is delivering satisfactory services in our district.
