Public Safety Committee Meeting Minutes

Wednesday, April 24, 2024

The Public Safety Committee met on April 24, 2024 at the district office and via Zoom Audio and Video Conference. The following board members were present: Angel Munez-Garcia, Carmen Rivera, Frank Franz, Jessii Parham, Kristine Rivera, Nicole Carter (virtual), Reggie Powell

The Public Safety Committee discussed the following information:

- Discussion of the following liquor license applications:

- **600 East 187th St LLC (Trade Name Full Moon Pizza) located at 600 East 187th Street, Bronx, New York 10458**

An application for a modification was submitted to include outdoor seating. An application for DOT's outdoor dining program has also been submitted. The committee will issue a favorable recommendation to the SLA for the liquor license.

- **Star Billiards Bar Corp located at 408 East Tremont Avenue, Bronx, New York 10457**

A new and temporary retail permit application was submitted. The business is under new ownership and previously operated under the name "Billar El Nuevo Ambiente Corp". The committee will issue a favorable recommendation to the SLA for the liquor license.

- **B&S Event Space Corp located at 412 East Tremont Avenue, Bronx, New York 10457**

The committee did not issue a favorable recommendation for a new liquor license. There have been recent noise complaints and violations by NYC Department of Buildings (DOB) that have not been corrected.

- **Zion Restaurant and Lounge Corp located at 4371 3rd Avenue, Bronx, New York 10457**

The attorney representing Zion Restaurant and Lounge Corp informed the district office that the application is being withdrawn and a new application will be submitted with corrections. The business is under new ownership. The District Manager will inform the SLA that the application is withdrawn.

- **806-808 East Tremont discussion**

The committee discussed the fire hazard posed by the layout of this illegal location. The committee received an update that FDNY had written a violation for the establishment being overcapacity on 4/20, and that the SLA was investigating complaints regarding 800 East Tremont.
