The Public Safety Committee met on March 27, 2024 via Zoom audio and video conference and in-person at the district office. The Public Safety Committee discussed the following information:

- Discussion of the following liquor license applications:

- **COATOMANTE INC. DBA GERBASI RISTORANTE TO MOISES RISTORANTE located at 2389 Arthur Avenue, Bronx, New York 10458**

Coatomante has applied for a liquor license renewal. Coatomante works from 11:30 am to 12 pm throughout the week. There was one 311 complaint for loud music but there were no concerns from the board. The board will submit a favorable recommendation for the liquor license.

- **Boca Restaurant & Steak House Corp located at 2458 Webster Avenue, Bronx, New York 10458**

Boca Restaurant has applied for a liquor license renewal. Boca Restaurant opens at 4pm from Monday thru Friday and they host Brunch on Sundays starting at 1pm. Their liquor license allows service of alcohol until 4am everyday. There was one 311 complaint for double parking. A board member wanted clarification on the type of surround sound that they have in which the business typically has live music and DJs. The board will submit a favorable recommendation for the liquor license.

- **Majestic Restaurant Inc. located at 709-711 East 187th Street, Bronx, New York 10458**

Majestic Restaurant operates from 11:30 am to 11 pm throughout the week. There are little to no 311 complaints at this location. The board will submit a favorable recommendation for this liquor license.

- Discussion on the complaints received regarding Portmore Link Up Lounge located at 800 East Tremont Avenue

The board previously had been alert to 806 East Tremont but they have been recently notified of lots of misconduct from 800 East Tremont as well. It is alleged that they do not have a liquor license but are selling liquor. This location has received an overabundance of complaints and the board will contact the SLA and the board will make a referral to the appropriate channels for Saturday night, when typically there are lots of complaints.
