- VI. ELECTED OFFICIAL'S REPORTS

Jeffrey Peña, Office of Bronx District Attorney Darcel Clark

Mr. Peña informed the board that the palm cards of the District Attorney's Office will contain all necessary information such as updates and are available to all at the sign-in table.

Santiago Baena, Office of New York City Council Member Oswald Feliz

Mr. Baena informed the board that Council Member Feliz's office held a hearing with the Mayor's office to learn more about what the City is doing to address the migrant crisis.

Christian Carduz, New York State Senator Luis Sepulveda

Mr. Carduz informed the board of several updates from Senator Sepulveda's office. The Senator's office has managed to pass bills that address retail worker issues and squatters. The budget has made allocated funds for healthcare issues and addressed building safety standards. In terms of community funding, the office managed to raise \$144 million dollars for community based organizations. On June 15, their office will be at Starlight Park from 12:00 PM to 4:00 PM for a Father's Day celebration.

New York State Senator Gustavo Rivera

Senator Rivera informed the board that the bill that focused on combating the overcrowding of the sidewalks by auto body shops has passed through senate but did not pass through the assembly. Next year, he will propose this bill again. Senator Rivera also worked to improve efforts to combat cannabis shops and he is requesting a list of stores from the community that should be targeted. Finally, Senator Rivera will be going on vacation thus his staff will not be able to be reached from July 1 to July 5.

Karime Vergara, New York State Assemblymember Karina Reyes

Ms. Vergara informed the board that Assemblymember Karina Reyes' office will partner with Senator Ferandez and Councilmember Farias to host an event on Tuesday, June 18 from 6:00 PM to 9:00 PM at 1315 Olmstead Avenue. Ms. Vergara also provided legislative updates. The Bill A894743, which focused on retail worker's safety, passed through the senate and is awaiting signature from the governor. Bill A6005 addresses water safety and is awaiting the governor's signature. Their office has continued to collaborate with the board and other members in support of residents of the Aquinas Developments. They hosted several events with agencies that are able to assist residents of the Aquinas Developments.

Ms. Nicole Carter, Economic Development Committee Chairperson

Ms. Carter informed the board at the previous meeting on May 15 they received a presentation about a local organization that proposed local movie theaters in the community. The committee issued a letter of support. The committee also intends to support board member Renee Reed's event proposal and she is advocating for everyone to participate for everyone to participate in the People's Money voting.

Ms. Margarita Espinosa, Environment and Parks Committee Chairperson

Ms. Espinosa informed the board that at the previous meeting on June 5, the board received a presentation from the Garden of Youth where the city is proposing to acquire the land where the Garden of Youth resides. The acquisition is intended to protect the garden by making improvements to the infrastructure and is currently supported by Council Member Feliz and several community stakeholders. The garden is already very active in the community, hosting several programs. The board will vote on this tonight. The Walter Gladwin Park plans for the recreation center did not contain a pool proposal thus the committee resolved to issue a letter that requests inclusion of a pool as a condition of support.

Ms. Kristine Rivera, Health and Human Services Committee Chairperson

Ms. Rivera informed the board that at the previous meeting on May 15 the committee received a presentation from Caring Kind, which hosts support services to people with Alzheimers and Dementia. The committee discussed the 5G tower where they advocate for better internet in this district however they displayed concern for the health implications. In the letter of support, they conditioned it that it should not be erected within 10 feet of residences. The committee also is sharing an aging survey to members of the community that ensures that senior's opinions are heard. The committee received a presentation from the Positivity Market where they offer services to help seniors with social services and closing the generation gap by providing technological help.

Ms. Maria Latimer, Sanitation Committee Chairperson

Ms. Latimer informed the board that at the previous meeting on May 16 the committee discussed the lack of trash cans in the district and the board resolved to engage in conversations with the city to address this shortage.

Ms. Lisa Sanchez, Transportation Committee Meeting Chairperson

Ms. Sanchez informed the board that at the previous meeting on May 16 the committee discussed the widening of a street on East 191st Street because of the difficulties of emergency response to navigate this street due to its narrowness. The committee also discussed the request from P.S. 51 for an open street from 7:30 AM to 3:30 PM. The committee expressed concern that the street closure could lead to traffic. Finally, the Cross Bronx Expressway project proposal was met with many concerns by the committee because of the historical failure to complete projects.

Kristine Rivera, Ad Hoc Committee Chairperson

The Ad Hoc Committee met on May 29 to discuss the hiring of management staff, shifting board meetings, and revised articles 8 through 10 of the bylaws, which will be discussed at the end of the meeting.
