# **PROPOSED MOTIONS FOR JANUARY 22, 2025**

**(Motions are subject to change.)**

- 1. A motion to issue a letter of support for High Hopes LLC program expansion into Bronx Community Board 6.**
- 2. A motion to adopt the minutes of Bronx Community Board 6's December 2024 Community Board and January 2025 Committee Meetings.**
- 3. A motion to amend Bronx Community Board 6's By-Laws to define the use of executive session at Community Board Meetings. Such a change will result in adding a new section, Section 10, to Article III of the By-Laws.**

**Article III, Section 10 of Bronx Community Board #6's By-Laws would read as follows:**

*“Sec. 10 – Any discussion of interpersonal issues between Board Members, including regarding Disciplinary Committee actions, must be done during an executive session. Board Members may not make motions from the floor of a Community Board meeting to enter into executive session. Board Members wishing to discuss an interpersonal issue in executive session must first contact the Board's Chairperson and district office at least seven days prior to a scheduled Community Board meeting. The Chairperson will then either approve the request or schedule the discussion for a future Executive or Disciplinary Committee meeting.”*

- 4. A motion to amend Bronx Community Board 6's By-Laws to require Board Members to provide notice to the Chairperson at least seven days in advance if they anticipate needing to depart early from any hearing or meeting. Such a change will result in adding a new section, Section 10, to Article III of the By-Laws.**

**Article III, Section 10 of Bronx Community Board #6's By-Laws would read as follows:**

*“Sec. 10 – Board members are required to provide notice to the Chairperson at least seven days in advance if they anticipate to depart early from a schedule hearing or meeting.*

- 5. A motion to amend Bronx Community Board 6's By-Laws to require that any notice to the Chairperson be submitted in writing to the district office. Such change will result in adding a new section, Section 2, Article V of the By-Laws.**

**Article V, Section 2 of Bronx Community Board #6's By-Laws would read as follows:**

*“Sec. 2 – Board members are required to provide notice to the Chairperson at least seven days in advance if they anticipate to depart early from a schedule hearing or meeting.”*
