**Meeting minutes of Wednesday, December 18, 2024**

**I. CALL TO ORDER:**

The December 19, 2024 meeting of Bronx Community Board #6 was held at the Fordham University, McShane Center, Room 303, Bronx, New York 10458, and was called to order at approximately 6:41 PM by Chair Evonne Capers.

**II. INVOCATION**

The meeting's invocation was delivered by 2<sup>nd</sup> Vice-Chairperson Laura James.

### III. COMMUNITY PERIOD

Individuals who asked to address the community board as part of the meeting's Community Period included:

#### Ms. Laura James

Ms. James informed the public of successful initiatives in Bronx Community Board 6 this year.

- Bronx Community Board 6 has been advocating for around shelter sightings in the district. There are a total of 26 shelters in the district. In addition, Senator Luis Sepúlveda recently introduced a bill that requires the New York City Department of Homeless Services to notify the corresponding community board prior to locating transitional housing for the homeless in their district.
- Council Member Oswald Feliz has raised 13 million dollars to renovate Bathgate Playground.
- Bronx Community Board 6 resumed its annual 5K run/walk at Walter Gladwin Park this past summer and made a donation to the American Diabetes Association.
- Bronx Community Board 6 worked with the new leadership at the Bronx River Arts Center (BRAC) to start a community advisory board with representatives from the Bronx Community Board 6, Bronx River Alliance, Drew Gardens, Bronx River Community Garden, Phipps Neighborhoods, Fanny Lou Hamer, and the Botanical Garden. Updates on the work of the community advisory board will be available at the start of the new year.
- Bronx Community Board 6 supported the 48th Precinct Community Council's National Night Out and Renee and Friends' Annual Thanksgiving Event for the community.
- Bronx Community Board 6 also supported the Story Garden Program at the Bronx River Garden, providing over 120 books to families.
- Bronx Community Board 6 supported the Bronx River Garden in their efforts to successfully prevent the construction of a 13-story building in the adjacent lot. The proposed building construction was replaced by a new one-story project.
- Bronx Community Board 6 is a part of a coalition of community groups led by the Bronx River Alliance that is working to make sure the Department of Transportation's Five Bridges Project is something that the community wants.
- Bronx Community Board 6 was successful in recruiting NIDC to help revitalize East Tremont through merchant organizing, which will be undertaken over the course of the year.
- Bronx Community Board 6 is assisting tenants from Aquinas Housing and has identified dozens of tenant leaders to mobilize organizing efforts in their buildings, a total of 46 separate properties.
- Bronx Community Board 6 is working with tenants at Lambert Houses. Last month they formed a tenants association, electing Board Member Annette Wright as president and a fellow tenant as vice president.

Derek Milan, representing the Tremont Library

Mr. Milan informed us that the West Farms Library will reopen on Monday, December 23, 2024. He also informed us that the Tremont Library will open an early literacy space and dedicated play area this upcoming spring. They are offering classes in partnership with NYC Speaks, where individuals are able to practice conversational English in a group.

Mr. Milan also inquired about organizations that provide interventions or assistance for individuals with a mental illness. District Manager Rafael Moure-Punnett recommended reaching out to 988, a dedicated helpline for individuals seeking assistance with mental health concerns, as well as contacting the emergency response team B-HEARD. District Manager Moure-Punnett offered to connect Mr. Milan with a representative of B-HEARD, which operates out of the Mayor's Office and responds to situations arising out of a mental health crisis.

#### **IV. BRONX BOROUGH PRESIDENT'S REPORT**

Bronx Borough President Vanessa L. Gibson's report was presented by her Deputy Director of Community Boards, Ms. Alexis Ruiz. Ms. Ruiz informed us that the Community Board Membership application will be available in January 2025. Ms. Ruiz also invited small business owners to participate in Bronx Restaurant Week, an opportunity to be featured during the "Sabor the Bronx" events taking place from February 18, 2025 to February 23, 2025. Ms. Ruiz also announced that Borough President Gibson will be hosting a Three Kings Celebration on January 6, 2025 and a baby rearing workshop on January 10, 2025.

#### **V. ELECTED OFFICIALS' REPORTS**

##### **New York State Senator Luis Sepúlveda**

Senator Sepúlveda thanked the elected officials who helped secure funds for Bathgate Playground, and shared updates concerning the legislative session starting in January. He also informed us about the services offered at his district office. He informed us that his office is able to assist constituents with housing, health care, public assistance benefits, or finding legal representation. Senator Sepúlveda also informed us that his district office will be closed from Friday, December 20, 2024 to Sunday, January 5, 2025. Senator Sepúlveda reminded constituents that he can be reached directly at his mobile number, which is (347) 582-8173.

##### **Santiago Baena, representing New York City Council Member Oswald Feliz**

Mr. Baena informed us that Council Member Feliz has tentatively secured 6 million dollars in mayoral funds, in addition to the 13 million dollars allocated by the New York City Council for the renovation of Bathgate Playground. He also informed us that Council Member Feliz will be hosting toy drives on Thursday, December 19, 2024 and Monday, December 23, 2024. Mr. Baena also invited attendees to their Three Kings event at the Botanical Gardens. Individuals can register for the event by calling their district office at (718) 842-8100 or scanning the QR code the flyer he shared.

##### **Karime Vergara, representing New York State Assemblymember Karines Reyes**

Ms. Vergara announced that Assemblymember Karines Reyes will be hosting her 7th Annual Three

**Kings Celebration on Sunday, January 5, 2025. She also informed us that new dates for the affordable housing ‘pop-up’ workshop are available. Individuals can register by sending a text message to the phone number listed at the bottom of the housing workshop flyer that she shared.**

**Jack Shaevitz, representing New York State Assemblymember Yudelka Tapia**

**Mr. Shaevitz reported that Assemblymember Tapia distributed over 1,000 turkeys and vouchers to residents. Assemblymember Tapia will host a toy distribution event on Thursday, December 19, 2024. Mr. Shaevitz also reminded attendees of the start of legislative session, which begins on Wednesday, January 8, 2025 emphasizing that Assemblymember Tapia will use this opportunity to elevate policy ideas. Their office is located at 2175C Jerome Avenue, Bronx, New York 10452 and their telephone number is (718) 933-6909. Mr. Shaevitz informed us that their office will be closed from Monday, December 23, 2024 to Monday, January 6, 2025. Mr. Shaevitz can be reached at (917) 414-5123.**

**Jeremy Peña, representing Bronx District Attorney Darcel D. Clark**

**Mr. Peña informed attendees that 175 coats were donated for NY Cares and expressed appreciation to all who helped with the coat drive. Mr. Peña also encouraged us to follow their social media platforms to learn about upcoming events and receive the latest news.**

**Raishiel Muñiz, representing United States Congressman Ritchie Torres**

**Ms. Muniz informed us that Congressmember Ritchie Torres wrote to the Panel for Education Policy (PEP) regarding the Specialized High Schools Admissions Test (SHSAT), urging the panel to approve the contract that would computerize the exam to avoid any delays and ensure fairness for all students. Congressmember Torres introduced the “Anesthesia for All Act,” a bill to prohibit health insurers from imposing arbitrary time caps on anesthesia services, ensuring access to medically necessary care with no delays nor denials on December 9, 2024. Ms. Muniz informed attendees that capacity has been reached for their toy giveaway happening on Friday, Friday, December 20, 2024 at the Bronx Zoo. Ms. Muniz also informed us that constituents can reach out to their office for assistance with legal, immigration and federal agencies services, including help with USCIS, Social Security, and IRS.**

**VI. CHAIRPERSON’S REPORT**

**Board Chairperson Evonne Capers’ Chairperson’s report included the following information:**

- Ms. Capers announced that two By-Laws amendments will be voted on tonight — an amendment to simplify the name of the Health and Human Services Committee by removing “Aging and Veterans” from the committee titled in the By-Laws and an amendment to create a Sanitation Committee.**
- Ms. Capers also announced that a By-Laws amendment proposal was being introduced to create rules around executive sessions. Board Members would be required to schedule discussions about interpersonal issues in advance, which would then be addressed at a future Board Meeting, Executive Committee Meeting, or Disciplinary Committee Meeting. This By-Laws amendment was proposed by the Disciplinary Committee at their last meeting.**
- Ms. Capers also informed us that a concern about board members sitting together as a group was brought to her attention at the last Community Board meeting. The Board’s By-Laws**

require members to sit as a group, but the Board must also accommodate members with medical needs. The member in question has since requested a reasonable accommodation to stand facing the front table, which Ms. Capers granted.

- Ms. Capers also explained that Board Members who have a medical issue that interferes with their membership should submit a reasonable accommodation request to the Board's district office. Ms. Capers recapped the Board's vote last month to conduct an investigation into absences and behavior in executive session.
- Ms. Capers appointed Board Member Carmen Rivera to conduct the investigation and anticipates the findings will be presented at the January Board Meeting.

## **VII. DISTRICT MANAGER**

Mr. Moure-Punnett's District Manager's report included the following information:

- Mr. Moure-Punnett clarified the parameters of how order will be maintained during meetings going forward and reiterated some notes from the Chairperson's Report last month on Robert's Rules of Order. When the Chair is speaking, we must defer to her. If members speak over the Chair, the Chair will ask them to come to order. If a member is asked to come to order by the Chair and refuses to do so, the Chair will then enter into the minutes of the meeting that the member is out of order.
- Mr. Moure-Punnett informed us the Disciplinary Committee is presenting a new set of rules tonight. One of those rules states that when a member is found out of order, the Disciplinary Committee will then investigate it.
- Mr. Moure-Punnett provided background on the closure of the Sanitation Committee and explained that the Board will be voting on reopening a standalone Sanitation Committee tonight.

## **VIII. TREASURER'S REPORT**

Ms. Marcano informed us that the Treasurer's Report for the month of December was included in the meeting packet. The report included expenses from November to December. She highlighted that \$200.00 was spent on art for the office, \$235.00 was spent for the food that was provided at the November Board Meeting and that \$179,000.00 remains in the budget for the fiscal year. Ms. Marcano asked individuals to review the report in detail at their leisure. She also encouraged organizations to submit funding proposals to the Community Board if they require funding assistance with programming in the community.

## **IX. COMMITTEE REPORTS**

### **Ms. Laura James, Disciplinary Committee Vice Chairperson**

Ms. James reported that the Disciplinary Committee discussed the concerns and the conduct of two Board Members during the election for Committee Chairs that occurred in October and clarified the cause of the Sanitation Committee closure. As a result of this discussion, the Disciplinary Committee determined that the Board Members that were previously found to be in violation of the Bronx Borough President's Code of Conduct are in fact in good standing, and that the previous notice was a warning only. The Disciplinary Committee informed the Board Members that they are in good

standing through an electronic letter. Ms. James also reported that the Disciplinary Committee has proposed a By-Laws amendment regarding Executive Session. They also reviewed and drafted their process and rules which were voted on that evening. Ms. James also reported that the Disciplinary Committee reviewed the Board's attendance records and determined the motion to remove a Board Member. This Board Member has missed four consecutive months of meetings, has not responded to phone calls, and is not reading emails from the Board. A wellness check with the New York City Police Department revealed that she is no longer living at her home residence. The Disciplinary Committee consulted with the Bronx Borough President's office and they in agreement with a motion to remove this Board Member.

#### **Nicole Carter, Economic Development Committee Chairperson**

Ms. Carter reported that the Economic Development Committee reviewed and discussed the Dining Out NYC Application for Enzo's of Arthur Avenue located at 2339 Arthur Avenue. After reviewing and discussion, the Economic Development Committee will issue a favorable recommendation to the New York City Department of Transportation. The Economic Development Committee also learned about the barriers that mobile car wash operators are facing to obtain their Car Wash License from the New York City Department of Consumer and Worker Protection (DCWP) in order to operate. As a result of the discussion, the Economic Development Committee would also like to hear directly from the mobile car wash operators to better understand the issues they are facing, formulate a position on the legalization issues, and discuss how to best advocate for mobile car wash operators. Ms. Carter also reported that the Economic Development Committee was informed that Neighborhood Initiatives Development Corporation is partnering with the New York City Department of Small Business Services to identify the needs and recommendations to improve the business corridor thriving commercial district along East Tremont Avenue and East 180th Street through a survey questionnaire.

#### **Ms. Margarita Espinosa, Environment and Parks Committee Chairperson**

Ms. Espinosa reported that the Environment and Parks Committee of the artist selection process including the panel composition, panel meetings and community board engagement timeline for the Walter Gladwin Park Recreation Center. The New York City Department of Cultural Affairs introduced the Environment and Parks Committee to artist, Glendalys Medina, who was selected to design the artwork at the Walter Gladwin Recreation Center. She presented the Past, Present, Future designs to the Environment and Parks Committee. The designs include flags as a point of reference and consecutively focusing on foreign nationals throughout the history of the East Tremont Avenue section of the Bronx. Ms. Espinosa informed us that the Environment and Parks Committee expressed the need for a more inclusive art design that includes additional colors that represents additional foreign national flags to the Past and Present designs, for instance, the African-American flag. The Environment and Parks Committee also had reservations about the flag illustration in the Future design. Ms. Espinosa also informed us that the Bronx River Community Garden presented their funding proposal for Adapt and Thrive, a winter to spring workshop series on climate change to the Environment and Parks Committee. This proposal is focused on supporting the health of the residents of the district. They informed the Environment and Parks Committee that in order to conduct these series of workshops at the Bronx River Garden they will need a total of \$2,800.00. The funds will cover presenter stipends, administrative costs, space rental, materials and supplies, and light refreshments. Ms. Espinosa also reported that the Environment and Parks also addressed concerns about dog waste at Quarry Ballfield to a representative of the New York City Department of Parks and Recreation's Bronx Borough Office and the matter is being referred to the appropriate staff for assistance.

**Kristine Rivera, Health and Human Services Committee Chairperson**

Ms. Rivera reported that the Health and Human Services Committee was informed about the outreach VIP Community Services has done to raise awareness about the Community Support Network. Their Community Support Network is a partnership with the Department of Health aiming to make resources in the district more accessible. The Health and Human Services Committee was also informed that in addition to connecting individuals with service providers, the Community Support Network offers ‘train-the-trainer’ sessions on topics including “Hypertension 101”, “NYC Social Mapping”, “Physical and Physiological Safety”, and “Coping with Emotions.” Ms. Rivera also reported that she briefed the Health and Human Services Committee about the important information on Black maternal health at the World AIDS Day Event held by the Office of the Bronx Borough President. She also reported that the Health and Human Services Committee was informed of a response from the New York City Department of Health and Mental Hygiene (DOHMH) regarding the request for information about health-related direct services offered in the district.

**Frank Franz, Housing and Land-Use Committee Chairperson**

Ms. Franz reported that the Housing and Land-Use Committee discussed the proposed plans to conduct a study to examine the zoning across the West Farms area of the district and advise the Board on whether to pursue a 197A plan. The Housing and Land-Use Committee also continued their work with the tenants at Lambert Houses. Mr. Franz also reported that the Housing and Land-Use Committee submitted a remark to support the opening of the Belmont Cove Development Project to be delivered at their ribbon cutting ceremony.

**Ms. Carmen Rivera, Public Safety and Licensing Committee Chairperson**

Ms. Rivera reported that the Public Safety and Licensing Committee reviewed the new liquor license applications for the following establishments: Chuito Restaurant and Bar located at 485 East 180th Street, M and O La Hacienda Events Hall located at 2481 Crotona Avenue, and Tacos and Restaurant Morena located at 2319 Hughes Avenue. After discussing and reviewing the applications and NYC311 complaints, the Public Safety and Licensing Committee will issue a favorable recommendation to the New York State Liquor Authority for these establishments. They also reviewed the renewal liquor license applications for the following establishments: Avenue Gyro LLC located at 2356 Arthur Avenue, Pasquales' Rigoletto Restaurant located at 2311 Arthur Avenue and Rancho Estrella Restaurant Corp. located at 616 East 187th Street. After discussing and reviewing the applications and NYC311 complaints, the Public Safety and Licensing Committee will issue a favorable recommendation to the New York State Liquor Authority for these establishments. The Public Safety and Licensing Committee did not have the opportunity to discuss the liquor license application for New Copas Lounge located at 894 East Tremont Avenue. They will review and discuss this application at their next meeting. Ms. Rivera reported that the Public Safety and Licensing Committee also reviewed the following all-night permits for New Year’s Eve for Aqua Bar and Grill located at 2241 Washington Avenue and Glitch Bar and Grill located at 441 East 187th Street. After discussing and reviewing the applications and NYC311 complaints, the Public Safety and Licensing Committee will issue an unfavorable recommendation to the New York State Liquor Authority for these establishments.

**Ms. Lisa Sanchez, Transportation Committee Chairperson**

**Ms. Sanchez reported that the Transportation Committee discussed the New York City Department of Transportation (NYCDOT)'s city-wide loading zone expansion, parking enforcement, and off-hour deliveries. The Department of Transportation is soliciting feedback from the public for locating new loading zones and offering incentives to businesses who participate in the Off-Hour Delivery (OHD) program. The Transportation Committee also discussed the "Multi-modal Community Connector" proposals obtained by Streetsblog through a FOIA request. However, the New York State Department of Transportation (NYSDOT) still has not provided a substantive response to the questions posed by the Board. The NYSDOT will return in January of 2025 to present design options on the 5 Bridges Project to the Transportation Committee. Ms. Sanchez also reported that the Transportation Committee discussed the outstanding requests and letter responses and the request to received an update on the recent traffic changes in the district.**

**Ms. Laura James, Youth and Education Committee Chairperson**

**Ms. James reported that the Youth and Education Committee discussed the need to develop a mission statement for their committee to better understand their objectives and plans. Ms. James also shared insights from the Fordham Leadership Academy's Fall 2024 Partnership Brunch. The Fordham Leadership Academy is a high performing public school in the district. The Youth and Education Committee will try to work with the school to identify ways that their model for success can be spread around the district.**

**X. ROLL CALL ATTENDANCE**

**A roll call attendance was taken confirming the presence of a quorum with the presence of twenty-one (21) members.**

- 2. A motion to support Bronx River Community Garden's Adapt and Thrive workshop series with \$2,800 was made by Ms. Angelina Zervos, seconded by Mr. Lamont Parker, and adopted by a vote of nineteen in favor, one abstention, and one opposition.**
- 3. A motion to adopt Bronx Community Board 6's Disciplinary Committee's rules was made by Ms. Evonne Capers, seconded by Ms. Nicole Carter, and adopted by a vote of twenty-one in favor, zero abstention, and zero oppositions.**
  - 3A. A motion to amend Bronx Community Board 6's Disciplinary Committee's rules to specify and include that the "behavior" stated in their rules is in accordance to the Bronx Borough President's Code of Conduct was made by Ms. Kristine Rivera, seconded by Ms. Carmen Rivera, and adopted by a vote of twenty-one in favor, zero abstention, and zero oppositions.**

4. A motion to adopt the minutes of Bronx Community Board 6’s November 2024 Community Board Meeting and December 2024 Committee Meetings was made by Ms. Margarita Espinosa, seconded by Ms. Nicole Carter, and adopted by a vote of twenty-one in favor, zero abstentions, and zero oppositions.
  - 4A. A motion to adopt the minutes of Bronx Community Board 6’s October 2024 Community Board, November 2024 Community Board and December 2024 Committee Meetings was made by Ms. Margarita Espinosa, seconded by Mr. Lamont Parker, and adopted by a vote of twenty-one in favor, zero abstentions, and zero oppositions.
5. A motion to amend Bronx Community Board 6’s By-Laws regarding the change of the name of the Health and Human Services, Aging, Veterans, and LGBTQI Committee to Health and Human Services Committee –

- J) Youth and Education”*

**was made by Ms. Magdamary Marcano, seconded by Mr. Lamont Parker, and adopted by a vote of thirteen in favor, two abstentions, and six oppositions.**

- 7. A motion to remove Board Member Clarita Bailon for failure to comply with Bronx Community Board 6's bylaws regarding attendance was made by Ms. Renee Reed, seconded by Ms. Evonne Capers, and adopted by a vote of eighteen in favor, zero abstentions, and three oppositions.**

### **XIII. ADJOURNMENT**

**There being no other business to discuss, the December 19, 2024 meeting of Bronx Community Board #6 was adjourned at approximately 8:20 PM.**
