The Economic Development Committee discussed the following:

- **Discussion on Letter of Support for Downtown Revitalization Initiative for Fordham Road**

The District Manager informed committee members that the Office of Bronx Borough President Vanessa L. Gibson and The Bronx Economic Development Corporation have submitted a joint application to the Regional Economic Development Council for the Downtown Revitalization Initiative (DRI) grant. Bronx Borough President Gibson requests a Letter of Support for the DRI application, which would provide funding capital projects that improve connectivity and economic growth in the Greater Fordham Road Corridor. The DRI area covers Bronx Community Boards 5, 6, and 7.
