Public Safety and Licensing Committee Meeting Minutes
Wednesday, August 27, 2025 at 6:30 PM

The Public Safety and Licensing Committee met on Wednesday, August 27, 2025 both in-person at the district office and via Zoom Video Communications. The following Board Members attended the Public Safety and Licensing Committee meeting: Nicole Carter (Virtual), and Reggie Powell.

The Public Safety and Licensing Committee discussed the following information:

- **Discussion on Liquor License Applications**

The Public Safety and Licensing Committee reviewed the liquor license applications for the following establishments: El Faisan De Oro Restaurant (Trade Name El Punto Del Salmon Restaurant) located at 1883 Webster Avenue, Grand Slam Banquet Hall at 478 East Tremont Avenue, Pollo Sabroso Sports Bar Corp. located at 855 East 180th Street, VBA Arthur Ave Inc. (Trade Name PIATTINI) located at 2363 Arthur Avenue, and Vivir Lounge Corp located at 625 Crescent Avenue. After reviewing the applications and discussing the relevant NYC311 complaints, the Public Safety and Licensing Committee will issue a favorable recommendation to the New York State Liquor Authority for these establishments.

A representative for Restaurant La Casa De La Morena located at 1967 Washington Avenue was not in attendance. Due to a significant number of NYC311 complaints regarding noise and loud music at this establishment, the Public Safety and Licensing Committee has decided to withhold its recommendation on their liquor license application. The Public Safety and Licensing Committee requests a meeting with a representative from Restaurant La Casa De La Morena to discuss these concerns before a recommendation can be issued to the New York State Liquor Authority.

- **Review of Temporary Event Permits**

The Public Safety and Licensing Committee reviewed the temporary event permit for Estrella Azteca Mexican Restaurant Corp. located at 2328 Arthur Avenue. This temporary event permit is for the sale of alcohol at the Ferragosto Festival on September 7, 2025. After a thorough review and discussion, the Public Safety and Licensing Committee has decided to issue a favorable recommendation to the New York State Liquor Authority for this permit.

The Public Safety and Licensing Committee also reviewed the temporary event permit Wildlife Conservation Society located at 2300 Southern Boulevard. This temporary event permit is for the sale of alcohol at Harvest Nights between September 25, 2025 through October 31, 2025. After a thorough review and discussion, the Public Safety and Licensing Committee has decided to issue a favorable recommendation to the New York State Liquor Authority for this permit.
