#### **Sanitation Committee Meeting Minutes**

The Sanitation Committee met on Wednesday, October 15, 2025 in-person at the district office and on Zoom Video Communications. The Sanitation Committee discussed the following:

### • Update on the Commercial Waste Containerization Program

The City has responded to pressure from the Board, local BIDs, and Council Members regarding the implementation of new containerization rules, which prohibit BIDs from placing trash bags on the sidewalk. The City will cover the costs to purchase trash bins for areas covered by BIDs, and BIDs will be responsible for ensuring trash is placed inside the containers.

## Review of the Bronx Community Board 6's Preliminary Community District Needs for Fiscal Year 2025

The committee reviewed the following items from the District Needs Statement: allocation of capital funding to renovate Bathgate Playground, street cleaning equipment for DSNY, requests for more cameras to curtail illegal dumping, previous efforts for an advocacy group to lead the request for a dog-run, request for NYC Parks Department to supply disposable dog bags, request for rain gardens, funding for more out-of-school programs and creation of vocational trainings for young adults, participation in Workforce1 Community Partnership Program, continuation of merchant organizing on East Tremont, maintenance and planting of street trees, increasing trash clean-up of local parks, and including a request for repairs of Belmont playground and the car safety service track around the field.
