Transportation Committee Meeting Minutes
Lisa Sanchez, Transportation Committee Chairperson
Thursday, February 12, 2026

The Transportation Committee met on Thursday, February 12, 2026 in-person at the district office and on Zoom Video Communications. The following board members attended the Transportation Committee Meeting: Nicole Carter (Virtual), Laura James (Virtual), Maria Latimer, Magdamary Marcano (Virtual), Jessii Parham, Kristine Rivera, Hoshi Salcedo, and Lisa Sanchez.

The Transportation Committee discussed the following:

- **Discussion on the Committee Vice-Chairperson Role**

The Transportation Committee discussed the need to appoint a Vice Chairperson in light of a potential bylaw amendment that would require committee chairs to attend in person when meetings are held in person. In that context, members suggested that each committee elect a Vice Chair to serve in the Chair's absence when necessary. Members emphasized the importance of having a designated Vice Chair to assist with meeting facilitation, coordination of agenda items, and ensuring continuity of leadership.

A motion to open the election for Vice Chairpersons of the Health and Human Services Committee and Transportation Committee was made by Magdamary Marcano, and seconded by Kristine Rivera. Hoshi Salcedo was unanimously elected Vice Chairperson of the Health and Human Services Committee. Jessii Parham was unanimously elected Vice Chairperson of the Transportation Committee.

- **Snow removal in the district**

The committee expressed concerns about the city's response to winter conditions and clearing of roadways. Several days after the major winter snow storm that fell on January 25-26, streets in the district were not passable nor safe for vehicular traffic. Likewise, sidewalks were not sufficiently cleared of snow and ice, absent of any usable path to access pedestrian ramps and crosswalks. These conditions affected overall accessibility and pedestrian mobility. Mounds of snow obstructed bus lanes and prevented MTA drivers from pulling up to the curb of designated bus stops. Buses were loading and unloading riders on the street beside oncoming traffic. It also appeared that plowing had exacerbated hazards for drivers as accumulated snow blocked off lanes of traffic. Mounds of snow also occupied parking spots or boxed vehicles in. The committee noted that snow melting trucks were underused in Manhattan and should have been reallocated to other boroughs in need. In the Bronx, the snow melting trucks were assigned for use at Orchard Beach, despite the existence of more critical areas in need of snow melting. The committee expressed interest in collaborating with the Sanitation Committee regarding snow removal in the district.

A motion to write a letter to Council Member Oswald Feliz, chairperson of the Committee on Public Safety in the New York City Council, about recent winter weather operations in the district and how to mitigate hazards in the immediate future was made by Magdamary Marcano, seconded by Kristine Rivera, and adopted unanimously.
