Captain Brown stated the following statistics:

Mr. Jay Baez, representing Senator Gustavo Rivera, spoke about the NYC Rent Freeze Program. The NYC Rent Freeze Program includes the Senior Citizen Rent Increase Exemption (SCRIE) Program and the Disability Rent Increase Exemption (DRIE) Program and helps those who are eligible stay in affordable housing by freezing their rent.
