48th Police Precinct Council Meeting Minutes

March 27, 2018 48th Police Precinct Claudette Coles, Law Enforcement Committee Chairperson

Captain Brown stated the following statistics:

- Overall crime rates within a 28 day period has increased by 11%.
- The homicide, rape, grand larceny auto crime rates are at 18%.
 It was notified that the rape crimes are occurring by an individual that the victims knows or by the victim's family members.
 - We were also notified that the grand larceny auto crime rates increased.
- The robbery crime rates has decreased.
- The year to present crime rates has decreased to 18%.
- The homicide rates within a 28 day period is at 1%.

We were advised not to leave any valuables in our vehicles including the glove compartment.

We were informed that there was a hit-and-run on March 19, 2018 in front of 4419 Third Avenue that killed an individual and injured another.
