Housing and Land-Use Committee Meeting Minutes  
Thursday, January 16, 2020

The Housing and Land-Use Committee met on Thursday, January 16, 2020 at the Bronx Community Board #6's district office located at 1932 Arthur Avenue, Room 403-A. At this meeting, the following members were present: Clarita Bailon, Virginia Bird, Evonne Capers, Julisa Hamilton, Laura James, Rosa Peraza, Reggie Powell, and Jacquetta Whaley.

The Emma Bowen Center presented on a proposed outpatient center on the ground floor commercial space of the residential building 2306 Webster Ave (bet. E 183rd and 184th St). The center would be open 6 days a week and provide individual counseling, family counseling, group counseling, mental health treatment, opioid overdose prevention trainings, group therapy, and more. Services would be open to Bronx CB 6 residents and Emma Bowen would seek the community board's input when hiring staff on site. It would not be a methadone clinic. The committee was in support of the project recommending a full board by the vote, with one member opposing it. Board member Reggie Powell asked for a list of similar facilities in the district which is attached to these minutes.
