Transportation Committee Meeting Minutes

Thursday, September 16, 2021 Ms. Lisa Sanchez, Committee Chairperson

The Transportation Committee Meeting met on Thursday, September 16, 2021 via Zoom Audio and Video Conferencing. The following members attended the meeting: John Barczak, Evonne Capers, Marilyn Gurley, Julisa Hamilton, Magdamary Marcano, Matthew Martinez, Rosa Peraza, Divine Sikanku, Lillie Steed, and Jacquetta Whaley.

The following items were discussed:

 Presentation by the Department of Design and Construction and Department of Transportation on the Devoe Avenue and East 177th Street Project

The Department of Design and Construction and Department of Transportation on the Devoe Avenue and East 177th Street Project presented on the Devoe Avenue and East 177th Street project. The Bronx River Alliance - Greenway Master Plan involves a 23 mile trail. The path from the mouth of the East River to the border of Westchester County is divided into five segments. This project connects Bruckner Boulevard including East Tremont Avenue and Starlight Park (Segment B) to East Tremont including Pelham Park (Segment C). With the project, the agencies hope to improve pedestrian/vehicle movements, to make shorter pedestrian crossings with refuge medians, to complete the Bronx River Greenway Connection between Starlight Park and Bronx River Park and to upgrade infrastructure. Widening of the Sheridan Expressway Bridge in the vicinity of Tidal Wetlands poses a challenge but agencies will coordinate with the Department of Environmental Conservation and New York State Department of Transportation to determine environmental effects and consider designs that reduce the impact to Wetlands. Another challenge is the point of interference at the Sheridan Expressway Ramp and the agencies will add a 7 feet encroachment with a 35 MPH vehicle design speed to address the issue. There are design coordination challenges with stakeholders as well and because of COVID the project was delayed from March 2020 to July 2021. Restarting the project requires backtracking, additional review by agencies with turnover in staff and revisions to design due to updated standards. An additional challenge is the elevated subway at East Tremont Avenue and Boston Road and to tackle this issue, the agencies will not raise the roadway; curb design will be restricted by the existing column; they may also mount additional lighting and consider visibility issues so that drivers can see pedestrians. The last challenge is the street lighting. The agencies will incorporate Flushing Meadows Park Pedestrian Lights to enhance lighting. New York City Department of Transportation has already taken some

temporary measures, including, restriping to allow for better pedestrian pathways, changing the signal timing to improve the flow of traffic, adding bus shelters and relocating bus stops for better access from the subway to the buses, and upgrading the lighting to LED. There will be a project information card, advisories, weekly bulletins and quarterly newsletters to keep the community informed and notified. They hope to have a stakeholder meeting in October 2021 and secure the design plans by Summer 2022, so that they can begin construction by Fall 2023.

Discussion of the street renaming of East 180th Street and Clinton Avenue in honor of Ms.

MARY MITCHELL BIOGRAPHY

Ms. Mitchell died in 1983 but her dream was championed by the neighbors she inspired. After a fifteen-year campaign, in 1997, the Mary Mitchell Center opened! The Center has developed after school youth programs, created The Food Justice Club and supports the effort of over 25 small, volunteer-run groups. Members of the Mary Mitchell Center Board have fought for thirty years to have vacant lots turned into ball fields and community gardens and to see local parks restored for soccer, tennis and football. Now, the Center provides many opportunities for youth and families during 2020 among the pandemic.

In the late 1970's Crotona, located in the South Bronx, was burning due to arson and property abandonment. Homes and buildings were reduced to rubble and the neighborhood had hundreds of vacant lots. While many people fled the devastation, some people insisted that they would not move, but improve their community. Mary Mitchell opened her home for families in need and engaged youth in sports and play activities on the street. She opened one of New York City's first Play Streets and had the vision to create a community center for youth and family activities to serve the Crotona community of The Bronx.
