**Request to Name Hudson Manor Terrace and West 237th Street for I. William “Bill” Stone
January 20, 2022**

Whereas, I. William “Bill” Stone meets the mandatory requirements for a Community Board 8 Street Naming by being deceased for greater than two years and has been nominated by three or more organizations which are on the list required to be kept by the Community Board under the NYC Charter;

Whereas, the location bearing the name change has a specific connection to his life as he resided nearby at 3801 Hudson Manor Terrace for nearly 60 years;

Whereas, I. William “Bill” Stone served our community as an active member of Community Board 8 for nearly 40 years and during his tenure chaired the Health & Hospitals and Libraries Committees and was Treasurer, Vice Chair and served three terms as Chair of Community Board 8. Additionally, he served on the Board of Directors of AHRC NYC providing much needed services for people with disabilities for nearly 50 years, eventually leading the organization as President for three of those years.

Therefore Be it Resolved, the Traffic and Transportation Committee of Bronx Community Board 8 supports the naming of Hudson Manor Terrace and West 237th Street in honor of **I. William “Bill” Stone**.
