The Chair advised that she, DM F. Kule-Rubin, and CB8 Chair J. Reyes had reviewed the CAP & EXP Priorities to discuss and consider the relevant factors in assessing the needs of CB8, including community input and historical context. It was noted that some Committee requests had necessarily been reordered to promote outstanding priorities over new requests with the understanding that new requests would remain in the queue for subsequent examination. Of particular interest was the possible expansion of NORC funding for senior centers District-wide and funding for swimming programs.

A brief discussion followed concerning whether a request for an NYPD Argus camera at Jerome Ave./Shandler Park was properly included among the District's priorities. E. Green proposed further investigation before the Full Board meeting which D. Travis agreed to undertake.

The Committee unanimously voted to submit the CAP & EXP Priorities to the Full Board and Members were advised that they still had time to submit any other comments to the Budget Chair and the office in advance of the June Board Meeting on June 25<sup>th</sup>.
