Chair Ed Green called the meeting to order at **7:00pm**

1. Introduction of Committee Members and Guests

Roll Call of Committee Members. Committee members introduced themselves.

2. Approval of the January 20th, 2026, Public Safety Committee Minutes

The January 20th Public Safety Committee minutes were approved unanimously.

3. NYPD Report (*See attached NYPD CompStat Report, Quality of Life Team Report, Traffic Report) –

Seargent Kresback read the NYPD CompStat report. Issues discussed:

- Three youths were shot and 1 was killed on 2/11/26 at West 238th Street & Broadway. A 17-year-old was arrested on 2/14/26 and charged with murder, two counts of attempted murder, manslaughter, two counts of assault and three counts of criminal possession of a loaded firearm. 3 other suspects are being sought. A prayer vigil will be held on West 238th Street & Broadway on 2/18/26 at 5pm for Christopher Redding, the 16-year-old JFK student that was shot and killed. The 13-year-old girl and 15-year-old boy that were shot are in stable condition.

- Bronx DA Darcel Clark will be invited to the March 17th Public Safety Committee meeting to discuss the incident, youth violence, and how young criminals are prosecuted in family court and criminal court. Felonies sometimes go to criminal court; other criminal offenses are directed to juvenile family court. In 2018, New York's "Raise the Age" legislation increased the age of criminal responsibility, typically from 16 to 18. Increased reoffending rates are concerning.
- A 16-year-old boy was slashed in the neck, and a 14-year-old boy was stabbed in the abdomen on Sedgwick Avenue near West 231st Street on 2/11/26. Two suspects are being sought by police.
- On 1/28/26, 4 teenagers were taken into custody for vandalism and attacking a store employee of the C-Town supermarket on Mosholu Avenue. Juveniles were released to their guardians. No arrests were made. Weekly incidents of vandalism, theft and harassment involving teenagers at C-Town have been occurring for months. Residents voiced concern about youths facing little to no consequences for crime.
- Police Commissioner announced the NYPD will be realigning the Bronx command structure by creating 2 patrol boroughs: Bronx North and Bronx South. The change will take place later this Spring. Initial reports are that more Officers will be added to the Bronx and Community Board 8 area.
- Resident disputed parking tickets he received and stated they were unwarranted. Officer guided him through incident protocol, individually assisted him and recorded his complaint.
- 50th Precinct stated many of the crimes being committed in the area are by repeat offenders and 7 of the 9 criminals with the highest rate of recidivism are currently locked up in City custody.
- Exotics smoke shop at 5586 Broadway was inspected by the Sheriff's Department and 2 summonses were issued but none for the sale of cannabis.
- Resident concerned about traffic safety near PS 81 School. Husband hit by car at the intersection of 254th Street & Riverdale Avenue. States she notified City Councilman and State Assemblyman about her concerns about child safety and requests for additional traffic safety personnel at the location.
- 2 dead and 1 critically injured in murder suicide at 2500 Johnson Avenue on 1/22/26. A 55-year-old man shot and killed his 59-year-old sister and critically wounded his 86-year-old mother before shooting and killing himself. Committee discussed raising awareness about mental health issues as a matter of public safety, what role mental health treatment facilities have in improving public safety, and potentially collaborating with the Community Board Health and Hospitals Committee.
- Student Reporter complaint about multiple noise incidents involving fraternity Delta Kappa Epsilon at Manhattan University.
- Resident report of abandoned and illegally parked vehicles on the streets for lengthy periods of time. Resident states people erase markings on cars marked for towing, so authorities won't know they're supposed to be towed.
- On 1/30/26 a man was reportedly laying in the street at 262nd Street and Broadway when he was run over by a car and dragged into Yonkers before being discovered underneath the car by the driver. The man was in critical condition at Jacoby Hospital at last report. The incident is currently under investigation.

4. FDNY Report

Battalion Chief Walters had to leave the meeting early because of an emergency at an undisclosed location. The FDNY statistical report was given to the committee:

In the Bronx Community Board 8 area for the month of January 2026 there were 26 structural fires, 9 non-structural fires, 321 medical emergencies and 313 non-medical emergencies.

Cars parked in front of fire hydrants were up 157% in the last 6 months in New York. In response, 10 criminal summonses were issued to people with cars blocking fire hydrants. Any person receiving this type of summons must appear before a Judge in criminal court and is subject to criminal prosecution. Fines varying from \$2,500 - \$4,000 were imposed by Judges.

5. FDNY Fire Safety Workshop

Topics discussed:

- Fire facts & statistics
- Common causes of fires (cooking, e-bikes, electrical, smoking, heaters)
- Proper usage of lithium batteries
- Smoke and combination alarms
- Knowing the type of building you live in
- Escape plans, based on the type of building you live in
- Closing doors if there is a fire
- Importance of obtaining a fire extinguisher in your home (various types)
- Overloading power strips

FDNY does not advise use of electric heaters or electric blankets.

Nothing that makes things hot or cold (ex. microwave, electrical heater, air-conditioner, hair dryer) should be plugged into an extension cord. Special extension cords that provide greater safety are available for various appliances.

FDNY advised people to hire a licensed Electrician or HVAC professional to modify electrical outlets, if necessary. It's a better option than overloading electrical power strips with multiple electrical appliances.

Caridad Restaurant, located at 135-45 Kingsbridge Road, applied to the Public Safety Committee to renew their license for liquor, wine, beer and cider.

Van Cortlandt Park Golf Course, located at 115 Van Cortlandt Park South, applied to the Public Safety Committee to renew their license for liquor, wine, beer and cider.

Representatives of NYPD's 50th Precinct stated they were unaware of any prior significant disturbances or complaints at the location of this establishment.

The Public Safety Committee unanimously approved this application.

Liquor, Wine, Beer & Cider

Blackstone Bar & Grill, located at 3713 Riverdale Avenue, applied to the Public Safety Committee to renew their license for liquor, wine, beer and cider.

Representatives of NYPD's 50th Precinct stated they were unaware of any prior significant disturbances or complaints at the location of this establishment.

The Public Safety Committee unanimously approved this application.

7. NYS Liquor Authority (SLA): Alteration Applications

Gemmy Quelliz, Owner of Bokagua, located at 3541-3543 Riverdale Avenue, appeared before the Public Safety Committee to apply for an alteration to her business.

The applicant stated she planned to expand the business and operate out of 3543 Riverdale Avenue, the retail space adjacent to their restaurant, as well as their current location 3541 Riverdale Avenue.

Representatives of NYPD's 50th Precinct stated they were unaware of any prior significant disturbances or complaints at the location of this establishment.

The Public Safety Committee unanimously approved this application.

8. NYS Office of Cannabis Management (OCM): New Establishment License

3 Guys Canna LLC: 6677 Broadway - Retail Dispensary Premises License

Tanvir Singh, a representative of 3 Guys Canna LLC, appeared before the Public Safety Committee to apply for a Retail Dispensary Premises License at 6677 Broadway.

The committee distributed flyers of the Public Safety meeting agenda in nearby residential and commercial units, notifying residents of their opportunity to attend the meeting and express their views.

Bronx Community Board 8 received 31 emails from community residents in opposition to 3 Guys Canna LLC, in contrast to 0 statements of support, and additional residents spoke at the Public Safety Committee meeting and urged the Board to disapprove the application.

Residents stated 6677 Broadway was an inappropriate location for a cannabis retail business because it would be adjacent to a 130 men's homeless shelter and have a disparate impact on a vulnerable population and potentially exacerbate mental health and substance use disorders.

Residents stated additional reasons for their opposition, including: the business would be across the street from a children's playing field in Van Cortlandt Park; a more appropriate location for the business would be in a commercial corridor instead of a residential neighborhood; the business will be adjacent to a bus stop used by children during school days; parking is practically nonexistent in the area and double parked cars will create a traffic jam near the city line where buses park and make U-turns regularly.

3 Guys Canna LLC is the third applicant to apply for an OCM license at this location since 2023 and the previous two applicants withdrew their applications.

In December of 2023, Bronx Community Board 8 passed a resolution recommending that recreational marijuana dispensaries not be sited less than 500 feet from community facilities such as homeless or migrant shelters, libraries, or parks.

The Public Safety Committee voted unanimously to disapprove this application.

9. Old Business

Update: 311 Flyer and Web Information:

A rough draft of a 311 informational flyer was created. The committee will finalize a flyer appropriate for distribution.

Committee will work with Bronx Community Board 8 Staff to enhance social media platforms and increase visibility of 311 information.

FY28 Budget Priority Requests:

Budget timeline changed by Budget Committee Chair. Committee will have an additional month to finalize budget items.

Agency response document was received on 2/17/26. Committee will review and consider agency responses when submitting requests.

Committee is still awaiting the 50th Precinct budgetary item list for FY28, including a list of new Argus cameras added after February 25th, 2025.

Additional lighting around the Jerome Avenue Reservoir was suggested as a potential budget item.

More tow trucks are needed to remove abandoned and illegally parked vehicles. Available funds for private towing contracts were discussed as a possible budget item.
