- Loud noise an ongoing issue
- 2 shootings: Marble Hill / 231<sup>st</sup> & Godwin on Columbus Day. One suspect was apprehended, another identified.

Other issues raised:

- Noise complaints and closing out 311 complaints before they are resolved.
- Rikers closing down. There has been talk about opening facilities in each borough to compensate.
- Crime in adjacent communities, specifically 34<sup>th</sup>, 46<sup>th</sup> and 52<sup>nd</sup> Precincts. Manpower is assigned to where crimes are happening.
- Cars going through stop sign at Kappock St. and Johnson Ave. Requesting more police presence at that intersection.
- Paper license plates & excessive vehicle noise.
- Catalytic converter thefts.

Captain Girven stated he has no control over placement of School Safety Agents and they are allocated under the School Safety Division. Captain Girven stated he would provide the Board contact information for the School Safety Division.

### 8. New Business

Homeless shelter at 6661 Broadway at 262<sup>nd</sup> St.

- Margaret asked if there were registered sex offenders in the shelter, would the 50<sup>th</sup> Precinct be made aware of that? Captain Girven stated he believes the 50th would be made aware.
- Stephen Vasquez inquired about checking 911 or 311 calls for current shelters for the purpose of assessing public safety risks.
- Ed asked if the committee can get some statistics on the correlation between general population shelters & crime and questioned whether our area would need more police presence if the shelter were built.
