c. Crimes on senior citizens are up

Phone scams – IRS, your relative injured, relative arrested. All asking for money. Epidemic of rims being stolen particularly from Honda Accords, Rav 4s. Captain suggested that people should invest in wheel locks

Grand Larceny Autos (GLAs) are up, but low compared with previous years

Assaults are up. Primarily due to domestic violence. Often children assaulting elderly relative. If the victim is over 65 it is considered Assault 2.

Shooting at 225 St in which there are 2 suspects. One was the victim who was arrested. He has a long robbery history and is on parole. The shooter has not been found yet.

Domestic violence is a serious problem in our community and a main reason for homelessness in this Community Board

The age at which a young adult can be treated as a juvenile is going up from age 16 years to 18. This will be effective next year.

Cases of children committing assault on grandparents or parents goes to family court. Phone scams are investigated by cyber-unit. Officer Cintron goes out on phone scam reports

## Regina Wilson, NYC Community Emergency Response Teams (CERT) gave a presentation on NYC CERT

The CERT program is associated with NYC Emergency Management

Community volunteers are trained by FDNY, NYPD, Emergency Management. The next training will be at Taft High School, starting on February, 4<sup>th</sup>. It is a 5 week program, 2 days a week. Ms Wilson acknowledged CB8 member David Gellman as a member of CERT. David commented that he did smoke detector installation.

CERT has a video about putting together a "go bag." The PS Committee stated that we would be very interested in showing this video along with a presentation to the community at a future PS meeting.

**CB8** and Barcelona Bites received a letter from the SLA stating that their liquor license was not going to be renewed. Their request for Corporate Change was removed from the agenda, they were advised of this prior to the meeting, but chose to attend the meeting. They stated their intention was to convince the PS committee that they are changing their business model and presented in a letter (attached) that they will abide by some specific stipulations. The point that this issue is in the hands of the SLA, not the PS committee, was stressed by Chair Donato. It was now the decision of the SLA.

Captain Melendez spoke about the problems occurring at the location, including public urination, noise, property destruction, etc. Several neighborhood residents came to speak at the meeting and talked about the same issues Captain Melendez mentioned. They said their lives have been miserable due to the activities going on at Barcelona Bites. We again stated and Captain Melendez reinforced that approval of the SLA request is not in our hands.

Officer Alvin Hunte introduced himself as the Transit NCO. His area is the Broadway #1 train from 242<sup>nd</sup> Street to 225<sup>th</sup> Street. Officer Hunte's email is: Alvin.Hunte@nypd.org
