BUDGET FY26-ELCA COMMITTEE- EXPENSE

Edu-NYPL – Continue 6-day service in branch libraries and serve as safe havens for after school activities for students.

The Chair reported that the SAT test will be administrated by digital only which could be a problem as it was this winter on a snow day. Deputy Chancellor leaving position, so Chancellor Banks is dropping the division which was going into effect next school year. It was a top priority to reshape how the city's elementary schools teach reading.
