#### 1. Introduction of Committee Members and Guests

New Committee Member Scott Krompinger introduced himself to the Committee and guests.

2. Approval of the June 14th, 2022 Public Safety Committee Minutes Approve in favor: 5 (C. Calhoun, E. Green, B. Kaplan, S. Krompinger, S. Villaverde) Opposed: 0

### 3. NYPD Report (\*See attached NYPD CompStat Report) -

Captain Girven, Commanding Officer of the 50<sup>th</sup> Precinct, presented the NYPD report:

- The majority of crimes in the 50<sup>th</sup> Precinct are larcenies.
- House of worship patrol discussed.
- Quality of life crimes discussed: Captain Gervin stated the Precinct doesn't have enough resources (Officers) to handle the volume of 311 calls and quality of life crimes reported, so issues are prioritized and Officers are assigned according to the level of severity.

- Various park locations were reported for multiple quality of life complaints, most notably noise: Northwest Playground at Broadway & 256<sup>th</sup> Street; 262<sup>nd</sup> Street & Broadway.
- Motorcycles reported on the Putnum Greenway and paved trail around the parade grounds.
- Complaint about groups of youths smoking marijuana on the city steps between 3800 Waldo Ave and 3660 Waldo Ave. Marijuana is now legalized. Not much NYPD can do.

### 4. FDNY Report

FDNY Battalion Chief, Gregory Lehr presented the FDNY report:

- Issues with E-Scooters and E-Bikes: Lithium Ion batteries are easily combustible and are causing many fires when these bikes are stored in apartments. These batteries are also causing fires in trash chutes, which is an improper method of disposal.
- FDNY did not have response time data available but will provide it at future meetings.

### 5. NYS Liquor Authority: Renewals

Efrain Farciert, President of Sante Fe Grill, located at 6025 Broadway, appeared before the committee:

Captain Gervin of the 50<sup>th</sup> Precinct stated there have been no notable complaints about the business.

Captain Gervin of the 50<sup>th</sup> Precinct stated this location has had multiple 311 complaints for noise, double parking and other quality of life issues.

The Committee voted unanimously to table this application until more information is provided, with regards to what measures the business is going to take to prevent the type of reported disturbances. Also, more information is needed regarding patron capacity for proposed alteration.

### 8. Old Business

Chair Green provided a recap of public safety issues during the summer break:

- BXCB8 had a table at National Night Out and discussed public safety issues with Officers and new 50<sup>th</sup> Precinct Captain Ozuna.
- According to the latest NYPD CompStat report, there has been a significant increase in crime in our area over the past year: Overall crime is up 66% and robberies are up 107%.
- Chair Green met with Congressman Adriano Espilliat, who expressed an interest in providing oversight, with regards to the 50<sup>th</sup> Precinct enforcing laws.

- Chair Green met with Bronx DA Darcel Clark and discussed BXCB8 public safety concerns, including quality of life crimes and prosecution of recidivists.
- Chair Green and BXCB8 Chair Laura Spalter attended Mayor Eric Adams' Community Conversation on Public Safety in the Soundview section of the Bronx, then had a follow up conference with Nora Daniel, Chief of Staff of the Mayor's Office of Criminal Justice, regarding community public safety concerns.

Hybrid meetings were discussed by the committee:

- Commanding Officer of the 50<sup>th</sup> Precinct, Captain Gervin stated recording devices were prohibited inside the Precinct, due to confidentiality issues, case sensitive, information, privacy of crime victims and those arrested, as well as various other security concerns, as per NYPD policy.
- Chair Green stated the 50<sup>th</sup> Precinct was his preferred location for the Public Safety Committee meeting, due to it's centralized location, easier access for the majority of residents in our community, and the abundance of 50<sup>th</sup> Precinct Officers specializing in specific committee issues, but he would be open to having the meeting at an alternative location if a community crisis or similar concern warranted it.
- Chair Green stated that unless an Information Technology Specialist, Board Staff Member, or PS Committee Member was willing to manage all technical aspects of facilitating a Hybrid meeting, he would not be in favor of conducting Public Safety Committee hybrid meetings.
- The Committee decided to table the issue of hybrid meetings, and possibly revisit it at a future date, if necessary.

### 9. New Business

Chair Green stated he would like the committee to spend a significant amount of time focusing on two areas of concern:

- Bail Reform law and its relation to increasing crime and public safety in our community.
- Mental Health Issues and their relation to crime and public safety in our community.

Committee Member S. Villaverde requested the status of Rikers Island (and its relation to our community) be put on a future Public Safety Committee agenda.

Committee Member B. Kaplan and Chair E. Green stated they would welcome a conversation about the status of Rikers Island and its relation to our community.

The use of 311 calls for quality of life complaints were discussed by the committee.

Chair Green stated that due to upcoming holidays, there would be no Public Safety Committee meeting held in October and the meeting will resume in November.
