Captain Girven presented the report:

2 rapes – domestic; robberies up; felony assaults up. Tremendous GLA auto increase. Anti-crime team has been expanded: One on evening and one on midnight shifts.

Chair Green asked if there is any news regarding the new establishments on Riverdale Avenue near 261st Street. There have been inspections from DOB. FDNY was notified to go to the establishment with Captain Girven to verify licenses.

Issue from Traffic and Transportation Committee: Double-parked cars during school hours at St. Gabriel's. Police have been writing tickets on the double-parkers at Johnson Ave and 235-236th St. Captain Girven stated he will speak with the Traffic Captain about this issue.

User2 (Marie Claude) brought up the issue of motorcycles and souped-up cars on Bailey Ave. Captain Girven stated his Officers have made 5 arrests and he requested installation of Argus cameras on Bailey.

8. Old Business

Prioritization of Public Safety Capital & Expense Budget Items:

Capital Budget Requests:

- Resubmit locations for Argus cameras that were requested last year.
- Chair Green asked Captain Girven if there are other areas where cameras would improve public safety.
- 259 & Riverdale Ave, 260 & Riverdale, lots of business there, SAR; Bailey & VCPS, Webb & Reservoir.
- Chair Green is requesting a master list of locations of cameras, maybe a map.
- Request FDNY EMS unit funding. David doesn't think that this is within our scope. David suggested not get too deep into it at this meeting, check with Ciara.

Expense Budget Requests:

Police Athletic League (PAL) after school program, youth crime prevention services:

• Captain Girven would love to see a PAL program here

- They have a program at JFK and have different programs each season (football, basketball, volley ball).
- Derwin Green of KHCC (After school program at Kingsbridge Heights Community Center) wants to be in partnership with NYPD.
- Officer Sala gave his contact info to Derwin Greene

Additional School Safety Officers for JFK High School:

- Captain Girven stated problems generally happen off-campus. Could use more School Safety Officers down there.
- Chair Green stated he will consult the BXCB8 Youth Committee for a possible joint budget request on this item.

School Crossing Guard at PS 95 (Hillman & Sedgwick):

• Captain Girven stated they are not paying enough salary, so no one is applying.

ATV for PEP Officers

Educational program for seniors: Phone scams, email scams, and check washing.

9. New Business

CB8 member David Gellman brought up issue of trucks parking along Jerome Ave extension of Major Deegan.

Captain Girven stated he was getting complaints, and the 50th Precinct is aware. Spoke with Yonkers PD. Traffic Officers have been writing parking summonses. They are already on it.

Discussion of Mayor's Blueprint to End Gun Violence report: (What effect will these policies have on law enforcement and public safety in our community?)

Ed asked Captain Girven if these proposed changes will have any effect on the 50th Precinct area. Captain Girven stated that our area doesn't have a lot of gun violence, compared to the rest of the city, so many of the resources mentioned in the report are unlikely to be provided to us.

Georgia Santiago stated that in 2019, a couple of Officers patrolled 11 buildings. Q: Do we still have the two Officers? A: There are 2 officers specifically assigned to Marble Hill & Ft. Independence. Two officers in sector B.
