Budget

Chair Spalter will work to update this information that will be updated on the CB8 website as a link from the SCRE report.

Sandra Lobo, Executive Director, Northwest Bronx Community and Clergy Coalition (NWBCCC), presented on its work in the community as a social justice organization. They work in housing/tenants rights, community land development, economic development, voter registration, education and offer an <u>agenda</u> that focuses on the advancement of the Bronx.

NWBCCC priorities in CB8 are housing, land use and youth issues:

- The goal is to keep tenants in their homes top causes for homelessness are lack of affordable housing and mental health issues.
- NYC Economic Development Corporation (EDC) took over the Armory agreement as of December 2021 and this is a huge priority for the entire Bronx. The Kingsbridge Armory

- is the world's largest armory and requires community engagement and benefit from whatever comes from this agreement.
- Youth need resources in the community. Schools require a reinvestment model, ensure nurses in every school, summer youth employment (SYEP), appropriate school safety measures.

NWBCCC are very interested to work with all committees of CB8 as they do with CB6 and CB7. All are invited to attend their annual meeting on February 12th to learn more: https://www.northwestbronx.org/

SCRE has a few gaps on committee assignments in other standing committees:

- Camelia agreed to attend T&T as official committee member, if Chair allows, or as regular board member
- Margaret agreed to attend LRE as official committee member, if Chair allows, or as regular board member
- Still have opening on HealthHSS

SCRE members are tasked with prioritization of equity in the Budget at each of their Standing Committees. SCRE members recommend all Committees to make their budget recommendations investing in areas of the Community Board that have been overlooked and underinvested. Laura/Margaret offer to do review of capital and expense as an analysis on budget investment from year to year to review, quantifying measure of how we serve the community.

SCRE members reviewed recommendations from the January 2021 SCRE Initial Report and will look more closely at them prior to our March meeting:

- SCRE and standing committees initiatives that address racial equity In-progress
  - SCRE member to formally attend at least one meeting of a standing committee to share research and/or gather information relating to racial equity and racial equity assessment - *In-progress*
  - Provide resources on topics to advance RE component of discussion unknown
  - Consider enshrining this process in the by-laws and ethical guidance manual of the community board - unknown
- Interim Report by May 2022 High-level updates/updated list of activities each year in May that is an addendum to existing SCRE report *In-progress*
- Identify and compile a list of equity-focused, community-oriented, and faith-based organizations that are interested in engaging in this work - *In-progress*
- Public Forum On hold
- Hold meetings in various parts of district On hold
- Training and ongoing discussion with Board members and staff on (un)conscious bias, structural racism - unknown
- Support increased diversity on CB8 through BP, public events, reach community where they are *In-progress*
