2. Chairpersons Report:

Chair asked to add two items to the agenda for discussion. Unanimoulsy approved:

- a. 3963 Saxon Avenue:
 - Letter from Van Cortlandt Village Citizen's Oversight Group showing failure of developer to send demolition notice to BXCB8 10 days in advance to the community board. One was sent to BXCB2 instead.
 - Developer Failed to provide statutory adequate notice of demolition and as of now Bronx Community Board 8 still did not receive a notice.
 - Committee unanimously agreed to send a letter to DOB and developer to either withdraw application and start anew or committee will request BSA to cancel Certificate of Occupancy.
- b. Discussion of electorate adoption of Charter Revision amendments adopted by Mayors Commission:
 - 2 proposals electorate adopted allow all powers of city council to be negated in favor of being centralized with office of mayor on ULUURP Process. Affordable housing not being addressed – no definition of what is affordable, need to define affordability, or how to go about making it affordable.
 - Zoning restrictions on R1 and R2 lifted with City of Yes. No regard for single family home use. No more single-family homes in NYC and in our district. Asked committee to think on this and will work on a resolution to ask Council members to support a resolution on a requirement that in the event a zoning lot merger is proposed they must give notice to community board more than 30 days in advance.
 - What is the future of our community and especially sensitive areas of Riverdale, Fieldston, Kingsbridge, Van Cortlandt Village, areas with single family homes?

Will discuss this at the next meeting and ask Council Member and Assembly Member to join - Do we believe in preservation of single-family homes and communities and what are the measures we can take given our limitations?
