# Introduction remarks by Chairperson of the Committee

### Department of Transportation (DOT) made two presentations:

- Update on Bailey Avenue Safety Improvement by Van Cortlandt Park South (VCPS) Phase 2 Presenters: Anthony Perez, (Bronx Borough Commissioner DOT), Mary Daly (Project Manager DOT), Daniel Wagner (DOT Director of Project Development Public Realm Unit) and Holly Malone (DOT)

Made some changes since the presentation made in November 2024 to remove the right turn access slip lane the board requested to keep.

DOT is working with DOT Harlem River Greenway Planning team who gives them insights from recent workshops. Addressing long crossing distances, lack of Pedestrian Crosswalks, safer expressway on/off ramps for pedestrians. Lack of pedestrian infrastructure. DOT is hoping to start construction this spring to be completed in Summer/Fall 2025.

DOT expressed that there are upcoming DOT projects in 2025 Van Cortlandt Park/Northwest Bronx Neighborhood Planning Analysis:

- 1- Van Cortlandt Park South and Bailey Avenue -Phase 2
- 2- Bailey Avenue (Van Cortland Avenue Park E. to W. Fordham Safety Improvements
- 3- Jerome Avenue and West 192 2<sup>nd</sup> street, 205<sup>th</sup> Street (not in our district)

### Other Agency Projects:

- 4- MTA/ADA station upgrade
- 5- Tibbetts Brook Daylighting
- 6- Kingsbridge Armory Renovation
- 7- Northwest Bronx School Safety Improvement
- 8- Woodland Playground

### Concerns/ Issues Raised:

Major Deegan off ramp concerns

- Turning radius too tight for 18-wheelers for Trucks making right lane turn
- Blocking on going traffic We requested data on the analysis
- Removal of a slip lane with a large development coming to the community will cause back up traffic.
- Is there a light for pedestrians so that pedestrians can feel safe crossing the intersection?
- Clarify Signage direction for Harlem River Greenway vs Putman

- Is it possible to have raised crosswalks for pedestrians for their safety?
- Issue with making turns safely, confusing which is a legal turn.

### **Bailey Avenue Concerns**

- Eliminating on average, 4-5 legal parking spots on each block
- Back -up of traffic when the bus is in the lane
- Right-hand turns is there a turning light vs Stop sign?
- Closure of Slip Lane may be an issue for cars making right hand turns

-DOT presentation on New Project Safety improvements on Bailey Ave from Van Cortland Park South (VCPS) to West 225<sup>th</sup> Street which includes protected bike lanes Chris Bronson and Nathan Albert (Project Manager)

Popular bike route with no connection to Park and Empire State Trail.

Killed or Severely Injured (KSI)- Stats are high on Bailey Avenue Issues:

- There was a robust discussion and opposition regarding elimination of 46 parking spots and how it would impact local businesses, increase traffic and the community ability to park could result in double-parking which is safety issue
- The community expressed concerns that street dividers from concrete places the community at risk of drainage /flooding risk
- Add a green pedestrian plaza to beautify the area on both-sides of the street.
- How would homeowner be impacted with this re-design with entrance or exiting driveways
- Concern raised regarding drainage and carbon neutrality
- Concerns with safety and crossing of the intersection
