- Address substandard conditions on the Summit and Heath Avenue Step Street.
- Improve draining system connection to nearby sewer.
- Bicyclist can

- Removal of existing trees and replacing them with a minimal amount of trees
- Parking spots will be impacted on Bailey Ave and Heath during the construction
- Privacy issues with those apartments are adjacent to the step street.
- The step street will be closed during the construction for approximately 30 months
- The walking distance for pedestrians will triple during the construction.

NYC DOT will implement corridor safety improvements on Bailey Ave.:

- Reduce a vehicle lane in both directions to organize the roadway, install new turn bays and turn signals to promote predictable and safer vehicle behavior
- Install pedestrian islands and curb extensions along the corridor to reduce conflict points with drivers, calm vehicle turns, and shorten crossing distance
- Install two-way parking protected bike lane along the west curb, adding 2.2 miles of dedicated space for cyclists and providing safe connection to Van Cortlandt Park
- New and expanded bus boarding islands for southbound Bx10 buses, improving service and rider accessibility

Implementation begins Spring 2025
