4. Dale Diner Dining Out NYC Sidewalk Cafe Application:

Miguel Angel Marta, co-owner with his brother, presented on Dale Diner 189 West 231st street and reviewed the details for the enclosed Sidewalk Café. The footprint will remain the same as before with three tables and 12 chairs in the enclosed sidewalk café portion. It is a fixed structure attached to the indoor restaurant. It has been in the same spot for many years.

There are no complaints from the 50th precinct.

WHEREAS, Dale Diner located on 189 West 231st Street, Bronx NY 10463 has submitted an outdoor dining sidewalk application to the New York City Department of Transportation (DOT); and

WHEREAS, Miguel Angel Marta, co-owner, appeared before the Traffic and Transportation (T&T) Committee on February 19, 2026, to provide details of their request which would allow them to use a portion of the public sidewalk (the sidewalk cafe); and

WHEREAS, the existing conditions with 3 tables & 12 seats, and the enclosed café size will remain the same as it has for many years; and

WHEREAS, there were no complaints from the NYPD or community.

THEREFORE, BE IT RESOLVED THAT, the Traffic and Transportation Committee of Committee Board 8, Bronx, unanimously supports the issuance of a permit to Dale Diner located on 189 West 231st Street, Bronx NY 10463 for a Dining Out Sidewalk Café permit.

Answer- They would need to Contact the Borough President Office to determine who is responsible for paving the particular roadways and street paths.

E. A citizen raised a concern on De-mapping and who is responsible for notifying homeowners.

F. The Business Owner of Sugar Bakery and community members raised concern regarding Bailey Avenue. The issues were the following:

- 1-Traffic on Bailey Avenue
- 2-Decrease access to Business due to no parking
- 3-Buses (BX10 & BX1) causing traffic when the bus stops at the bus stops
- 4- Double parking

5- Business are closing-down on Bailey Avenue

DOT expressed they are willing to explore study for curb use and also explore working with the 50th Precinct traffic enforcement
