R. Kaplan – Asked about hate crimes that occurred over the weekend. Case is still open and being investigated as bias incident. Clean-up project is being organized with NCOs and Graffiti Coordinator. Also – The appearance of paper license plates has increased – What is being done to interdict these plates. A: There is in place a "paper plate initiative" where the validity of the plates are checked. Multiple arrests being made. Kaplan asked where can we report them? Call the precinct or call 311.

M. Joyce - Commented on the proliferation of motorized bikes being driven on sidewalks.

Ed – Spoke about the "club" that opened at 6048 Riverdale Ave. Public Safety Committee chair Ed Green, Fr. McCarthy from St. Margaret's, CB8 District Manager Ciara Gannon, CB8 Chair Laura Spalter, and representatives from the 50th Precinct (Girven, Sala, Jamsheer) did a walk-through of the site. They expressed that there are fire safety concerns. This is a recording studio. Space heaters were found in recording studio, no signage and no permits. The business has been open since December. Neighbors are complaining about excessive noise. St. Margaret's parishioners have been voicing concerns. Illegal parking in church lot.

Officer Sala stated that the whole block is opening up to several businesses. Smoke shop opening up. Trying to figure out what that block will look like. Waiting for paperwork so they can send it all at once. They are aware they will be checked up on and under scrutiny by the Community Board. Ed Green stated that we will follow up on these things. What are the deadlines? How long can businesses operate without permits in place.

Ed another issue: "Friends of West 254th Street" between Independence and Arlington contacted the Board office re buses, illegal parking. Officer Sala stated he will look into this.

Communication from CM Dinowitz's office re 226 West 242nd St: Loud parties, patrons urinating and leaving garbage. There have been 15 311 calls. Aurelia Taveras represents that place Tiajuana Nights (El Polecon). She stated they are adding a manager and are aware of the issues. They are also raising prices to attract a different clientele and trying to discourage the college student crowd. Officer Sala says they are aware there are issues. A. Taveras says they have security to get people moving away from building.

- Bail Reform Laws Discussion of statistical analysis:
 - o Statistics came out, then modified because not broken down correctly.
 - 41% in supervised release were rearrested before their cases were closed. 23% rearrested on felony charges while cases pending.
 - S. Vazquez says resources need to be reallocated to address the core problem: It's a larger issue than just law enforcement.
 - Bob Kaplan stated bail reform has not affected the rearrest rate. There has been a rise in crime nationally and everyone is pointing to bail report as the cause. He suggested we should bring in experts to tell us the arguments (pro and con).
 - S. Vazquez stated we request J. Dinowitz, A. Biaggi, and/or Richie Torres come to our Public Safety Committee meeting and speak about the issue.
 - o D. Gellman suggested the Committee write a resolution.

8. New Business

Discussion of Public Safety Budget request items:

- Chair Green requested suggestions from the committee.
- NYPD sent information about what budgetary items are needed for Public Safety.
- Officer Sala suggested community-based initiatives. Youth-oriented; they had a handball event at VCP. Resources for youth-crime prevention programs.
- Ed suggested the committee have a joint budget request with Youth Committee.
- Ed asked committee members to email him with any budget ideas.
