Captain Girven was promoted from 2nd in command to Commanding Officer

- A lot of property crimes, mostly vehicles.
- Check washing: Related to scams. There are lots of scams happening to seniors. Chair Green requested that the Community Affairs Officer give a presentation on this topic. She is working with Postal Inspectors to address "fishing" in mailboxes. Thieves are bypassing the new technology and getting mail out of boxes.
- Ted Morris: Asked if the victim in the fatal hit & run at 262nd Street was homeless. Person was not homeless. Yonkers resident. Police identified the car and have person of interest.
- Other items addressed included:
 - o Relationship the 50th would have with the proposed men's shelter on 262nd & Broadway.
 - o Recent bust on Mosholu Ave: \$4m heroin, weapons, ammunition, etc. were found.
 - New Government policy: How press credentials are being controlled by Mayor's office.
 - Shooting at Marble Hill.

4. FDNY Report

Captain Paul Colabella gave a fire prevention presentation:

- Shared city-wide trends:
 - Entering holiday/heating season. Fire goes up this time of year.
 - o 65 fatal fires per year. 2021 approaching 60 fatal fires.
 - A lot more seniors this year.
 - Make sure everyone has upgraded smoke detectors.
 - Newer smoke detectors have batteries that are hard-wired into them.
 - FDNY has thousands of smoke detectors, installing and providing for free.
 - 60% more likely to die without a working smoke detector.
 - 1-877-redcross (Red Cross Sound the Alarm Program).
 - Electric stoves are dangerous.
 - Lots of fires due to overloaded power strips.
 - When done with an appliance, unplug it. Done with the toaster, unplug it.
 - LED lights burn much cooler put in lamps.
- Questions to Captain Colabella included:
 - Close apartment doors behind you if you have to get out of the building.
 - Power strips. Can you recommend alternatives if don't have enough wall outlets. There
 are no alternatives. Power strips: phone charger, clock, lamps. Surge protector is no
 better. Suggests calling Electrician to install new outlets.
- Black soot around wall sockets is a danger sign that something is wrong. May have loose outlet or wires behind the outlet are loose. Something that must be addressed.
- Don't push furniture (couch, bed) up against electrical wall outlet.

Discussion of SLEEP Act: Amendment of traffic law, increasing penalties against motorists and repair shops that illegally modify mufflers and exhaust systems to make them excessively noisy.

- Fines for shops installing noisy accessories. Ed feels there needs to be enforcement at the
 motorist level. Ed asked Girven, how will noise be measured and motorists be fined. Vehicle
 traffic enforcement. In past 2 weeks, they seized two vehicles with excessively loud exhaust.
 They had moving violations. Reckless driving. That's why they were stopped in the first place.
- Nick stated the loud noises sound like they are being amplified through a sound system.
