In response to inquiries DI O'Toole said that anyone experiences a problem with the State Police could report it to the precinct.

Five individuals were slashed in an incident at Silhouettes, 5668 Broadway. The incident started in the bar and went out to the parking lot. Six people were arrested. DI O'Toole praised the owner of Silhouettes for his cooperation.

In the last 28 day period there were 41 arrests.

Grand larceny remains the biggest problem.

There was 1 fatality on Major Deegan, a woman walking on the Deegan. DI O'Toole said the police do not know why she was walking there.

Burglaries have been reported around the Knolls Crescent area. Arrests have been made.

DI O'Toole was asked if there were any ICE arrests and he said there were none. There were incidents of smashing of windows - criminal mischief. 2 weeks ago an arrest was made.

The department knows where these are occurring and have an unmarked car on patrol.

Daphne Kohavy spoke about the city staircase from Irwin Avenue complaining that the lights were out during a construction project there. She asked they be turned on. DI O'Toole said he look into it.

Threats were called in to Jewish Centers, including the Riverdale Y. DI O'Toole spoke with the temple by RKA.
