A woman who jogs in VCP asked if the police could do a run around on the jogging path (not the track) because there have been a few incidents. DI O'Toole said they do a run around, but the speaker said they don't cover the whole trail.

Liquor Licenses – New Applications

Moonstar Grill, 3519 Johnson Avenue

Wine and Beer License request. This restaurant has been at this location for over a year. They are primarily a restaurant. There is no bar at the location, just tables.

Truffa Pizzeria and Wine Room, 3535 Riverdale Avenue

Wine & Beer license currently held, they are now applying for a full liquor license. This location has been home to 2 previous Italian restaurants and has had no issues in the past. They are in the process of applying for a sidewalk café permit. The restaurant is open until 2 am but they often close by midnight. They did state they want to stay open until 4 am, but were advised by the chair that in the first year of the license they must close at 2 am. The only music recorded is ambient music. Noise is not an issue.

Mis So-Melo Lounge, 4685 Manhattan College Parkway

This location, formerly "The Lounge" has been leased to new owners. Danielle Ellerbe is representing the owners. Committee Member, M. Joyce pointed out that this location has been the source of numerous complaints (noise, public nuisance, public urination, etc) for many years. Ms. Ellerbe stated that they are aware of the past situation and they will try their best to keep things like that from happening. They are installing soundproofing insulation. There were many people from the neighborhood around the location who came to speak out in opposition to the granting of a liquor license. The major concerns are noise, fights, loitering, urination, etc. The geography and building configuration of the street is such that noise is magnified and echoes off the building. A woman who lives directly across the street did some research into the zoning and building codes for that address. It appears that the location is not zoned for a restaurant. The Certificate of Occupancy shows that the basement is for a "retail store", first floor is "accessory storage" and the second floor is for "office" space. There are also several outstanding DOB violations against the building.

The committee unanimously voted to table the SLA request and look into the building and zoning restrictions and take it from there.
