Members introduced themselves

Captain O'Toole gave the 50th Precinct Police Report

- All compared to last 30 days:
 - o 1 rape, down 1
 - o 12 vs 10 bank robberies
 - o 8 vs 5 felony assault
 - o Grand larceny is down by 2 over last month
 - o 4 vs 5 grand larceny auto
 - o The 50th Precinct is up 8 crimes for the year
- In response to a question Captain O'Toole replied that the precinct is not in the Vizion Zero zone.

FDNY Report given by Battalion Chief Paul Jirak

- Year to date compared with corresponding period in 2015:
 - o Responses down from 559 to 537 this year.
 - Structural fires up 11%: 28 to 31.
 - o Numbers are relatively unchanged for non-structural fires.
- Chief Jirak stated that Battalion 27 encompasses CB 7 and CB 8

 Bob Press asked asked if they are still getting gas leaks reported. Chief Jirak replied that responses have gone up tremendously, mostly due to a greater awareness of the issue.

Liquor License Renewal

- Van Cortlandt Golf Course, represented by Steve Ring
 - o No incidents or problems this year.
 - One burglary last year.
 - Café opens at sun-up, closes at sundown, usually between 7:30 pm to 8:00 pm.
 Mr. Ring said that while the cafe opens early, alcohol is only served during legal hours.

New Beer and Wine License

- Caribbean Grill, represented by Wendy Reyna, new owner
 - Located in the Van Cortlandt Motel at 6393 Broadway, next door to Riverdale Manor restaurant is open 6:30am until 8:00pm.
 - Robert Press expressed concern that the residents of Riverdale Manor would come in for drinks.
 - Ms. Reyna is taking over as a new owner and she had not been working there
 previously under the former owner.
 - o Capacity is two 4-chair tables, two two-chair tables and four counter seats
 - Tom O'Connor asked about her experience selling alcohol. Ms. Reyna stated that she has none. She was asked if she has a scanner for IDs. She replied that doesn't have a scanner. Upon the recommendation of the committee she will obtain a scanner.

Application was unanimously approved (Joseph O'Brien, Margaret Donato, Robert Press, Mary Yamagata, Myra Joyce).
