Chair Spalter convened the meeting at 6:40 PM and welcomed all. Budget Chair, D. Gellman commenced the Public Hearing on Responses from City Agencies on the Capital/Expense Budget Priorities for FY 2022.

The following community residents and stakeholders spoke in response to the budget responses:

• Stephanie Ehrlich (Van Cortlandt Park Administrator) asked for support in restoring the Van Cortlandt House Museum Fence Restoration Project as well as the Red Steps Restoration Project. Ms. Ehrlich also asked for support to increase the Van Cortlandt Park Operations Budget.

• Christina Taylor (Van Cortlandt Park Alliance) thanked everyone who has been volunteering in the park during the pandemic. The Alliance is seeking discretionary support to continue keeping the park clean through their volunteer program. They are also seeking support to continue providing environmental educational programming for youth and school children as well as cultural programs like the Enslaved People's Project and Barefoot Dancing.

• Tony Edwards (Marble Hill Houses) inquired about a discrepancy in an allocation for Budget Infrastructure Repair of \$1.1M (\$12.6M - \$13.7M). C. Gannon has an inquiry in with NYCHA and will relay their response to Mr. Edwards upon receipt.

• Paula Frye (Property Manager at Marble Hill Houses) spoke about concerns around the parapet wall, the facade, watermain (leaking into apartments), tripping hazards throughout the interior as well as problems with the boilers (heat & hot water).

• Deidre Burke expressed dismay around the lack of Parks capital budget. Seeking support for DSNY's ability to dispose of hazardous and e-waste. She also spoke about the need for cameras and enforcement to address speeding.

• Rebecca Brown Barbier (Manager at Riverdale & Spuyten Duyvil NYPL) – seeking support for 6-day service as well as programming.

• Sydney Renwick (NYPL Associate Director for Government and Community Affairs) spoke about a capital project at the Riverdale branch \$1.7M for ADA upgrades for bathrooms and interior façade currently in the procurement process. Capital project upgrade for complete renovation for Spuyten Duyvill.

- D. Gellman closed the budget hearing at 7:02PM.

- 2. REPORT FROM THE BRONX BOROUGH PRESIDENT'S OFFICE Ishrael Gonzalez
 - The Borough President's monthly report was distributed.
 - At this time, no new Community Board membership applications are being accepted.
 - Welcomed new community board members and reminded existing members that the application renewal deadline was Friday, February 5th. Please submit your renewal applications asap if you have not done so yet.

3. REPORT FROM THE 50TH POLICE PRECINCT – Officer Conejo

- The monthly crime statistics are: 0 murders, 1 rape,9 robberies, up 50% from last year, 12 felony assaults, up 9%, 6 burglaries for the year compared to 9 last year, 29 grand larcenies, 3 grand larceny assaults, down 80%
- Board Members asked questions regarding speeding, shot spotters and budget priorities. Officer Conejo will pass them along to Captain Melendez.

4. REPORT FROM ASSEMBLY MEMBER JEFFREY DINOWITZ

- His office has received complaints regarding appointments for COVID vaccines at Yankee Stadium; this site is open to the entire Bronx.
- Office is open and seeing constituents by appointment.
- State budget does not look good, cuts promise to be severe unless we receive a massive infusion from the Federal government. Raising taxes on the very wealthy may be necessary. C. Moerdler recommends income generation such as air rights.

5. REPORT FROM CONGRESSMAN JAMAAL BOWMAN

- The Congressman expressed that after the insurrection on January 6, there has been incredible collaboration, communication and unity within the Democratic party.
- He introduced his first bill, "The Congressional Oversite for Unjust Policing (COUP) Act" in response to the lack of police and level of resistance in comparison to BLM protests. Congress is asking for a 9/11 style commission to investigate exactly what happened.
- Recently elected as vice chair of Education & Labor committee and sits on the Science and Technology committee.
- The District office is open virtually and the Congressman along with his staff are eager to get to work for the community.

6. CHAIRPERSON'S REPORT – LAURA SPALTER

• Refer to Executive Committee minutes for the full report. Chair Spalter stated that she asks everyone to be mindful of the time. Aim to end tonight's and all future full board meetings by 9:00pm to be respectful of the public and board members. Remote meetings have been ending very late.

7. TREASURER'S REPORT – DIOMARYS ESCANO-BELL

• D. Escaño-Bell provided an overview of the report and noted that we've allocated \$118,175 with \$134,212 remaining for FY2021. The asterisk refers to a pending transfer to OMB of \$3,628 in response to the City's goal to eliminate budget gaps.

8. DISTRICT MANAGER'S REPORT – CIARA GANNON

- DM Gannon referred board members to the Executive minutes for an extended report.
- Working closely with the Land Use committee on projects in the district.

- At the District Services Cabinet meeting the Parks Dept agreed to clean up Bailey Triangle with local volunteers taking care of ongoing maintenance.

9. REPORT FROM DEPARTMENT OF CITY PLANNING - NONE

Secretary L. Daub conducts Roll Call. A quorum is present with 35 board members.

10. COMMITTEE REPORTS:

A. LAND USE – C. G. MOERDLER

- Thanked C. Gannon for the work she has done to help make the work of the Land Use committee possible this year.
- The Land Use committee will be working on a planning and zoning project with the help of Rosemary Ginty. They will focus on Dash Place, Kingsbridge area/ Claflin Av and Webb Avenue.
- C. Moerdler thanked D. Travis for her work on the Webb Avenue project. J. Reyes will lead work on issues surrounding proposed development on NYCHA grounds.
- We have ascertained that the Department of Traffic is responsible for the right of way and repair of rockslide along Henry Hudson Parkway, not the property owners.

B. TRAFFIC & TRANSPORTATION – D. PADERNACHT

- Next meeting is Thursday, February 18, Con Edison to update the community on current projects including North Riverdale.
- We have received complaints about DOT making changes without notifying the board or the community, such as speedbumps on Palisade Avenue near the Hebrew Home and new daylighting signs near Amalgamated. This issue will be on the agenda.

C. YOUTH – J. GOMEZ

- Next meeting date is Monday, March 15.
- The committee will continue to explore how to expand current free Wi-Fi network.
- Thanked R. Singh for agreeing to be Vice Chair.

D. AGING – E. DINOWITZ

- For older adults, vaccinations have been tough to schedule. The Board sent a letter to Mayor de Blasio asking him to create a portal to allow senior centers to directly schedule appointments for seniors. The request was echoed by our senior centers.
- A representative from DFTA attended our last meeting. We suggested sites in the district and will continue to forward suggestions. Transportation to vaccination sites is available through Aging Connect. Scams are still rampant.
- Next meeting scheduled for March 18.

E. BUDGET – D. GELLMAN

- FY2021 ends June 30th
- The board will send a budget response letter for FY2022 to the Mayor and OMB.
- Embarking on Fiscal / Budget year 2023 Expense / Capital budget priorities in development.
- L. Spalter added that we have 29 Capital projects that were submitted in April: 8 are in Riverdale/Spuyten Duyvill area, 18 are distributed throughout the rest of the district and 3 are in Van Cortlandt which is a regional park. The committees are being sensitive to needs throughout the entire district.
