3. Guest Speaker: Bronx District Attorney's Office Representative

Representatives responded to questions they received in writing from the PS Chair.

- How do the bail reform laws impact overall crime stats: Only a small proportion of crime has been attributed to criminal justice reform, most is due to pandemic situations and are borough-wide.
- For misdemeaners there is no remand except for bail jumping, criminal obstruction, endangering welfare of a child, felonies – witness tampering, witness intimidation, sex offenses.

- Is "dangerousness" included in setting bail? Cash bail is supposed to ensure that someone at risk of flight will not be able to flee. Dangerousness is not included in the determination. The decision is not up to the judge.
- If a defendant commits a crime while awaiting trial for a crime the Bronx DA will generally recommend consecutive sentences.
- Should burden of discovery be on the defense? No, the burden is on the prosecution. Never shifts to the defense.
- Is there accountability for judges? OCA has listing of all judges, statewide, countywide.
- Question from committee member Nick Fazio: How does our crime compare to other cities? Citywide up 40%. Bronx, shootings up 30%. Homicides are up in major cities all over the country.
- Question from Nick: What happens if the prosecutor doesn't meet the timeline for discovery? Judge could dismiss the case.
- Question from Sergio Vilaverde: Is bail jumping a qualifying offense for a bench warrant, if defendant dosen't come back in 30 days it is a separate crime? Court reevaluates conditions of release.
- Jyll Townes, PS Committee Member asked: What initiatives has the DA implemented with regard to racial equity? Sonja answered: Ramped up on re-entry initiative, providing resources for people re-entering society.
- DA's office is partnering with The Fortune Society. They participate in case conferences every month. Fortune society provides services. Nick asked if there is data on recidivism: Sonja said Fortune Society has that data and she would get it for Nick.
