L. Spalter convened the meeting at 7:04 PM and welcomed all to this month's Board Meeting.

#### 1. GALLERY SESSION:

Chris Rizzo, Riverdale Main Street Alliance, read a letter of support for the Vision Zero Calming Plan for Mosholu Ave. The alliance appreciates the work of the Community Board. However, he underlined the alliance's concerns regarding Riverdale Avenue.

Victor Cruz, Director of Community Affairs, Grace Church in Marble Hill invited the public to a nutrition workshop on May 20 at 6:30pm.

Deidre Burke expressed her gratitude to the Traffic & Transportation Committee for the careful deliberation regarding the proposed changes to Mosholu Avenue. Ms. Burke expressed that nobody is against traffic safety, but the proposed plan is wrong. She feels that more studies are needed.

Janie Lerner from the Seton Park Dog Run Group introduced her group.

#### 2. REPORT FROM THE BRONX BOROUGH PRESIDENT OFFICE – Ishrael Gonzalez

Mr. Gonzalez reported that the former Deputy Borough President Aurelia Greene passed away. The monthly report was sent to all. The Borough President's office has sent out the reappointment letters to board members.

# 3. REPORT FROM THE NYPD $50^{TH}$ PRECINCT – Captain Emilio Melendez

Captain Melendez reported that the 50<sup>th</sup> Precinct is #1 in crime reduction. Overall crime is down in most categories in the 50<sup>th</sup> Precinct except for rape. The captain expressed that the district is very fortunate to have such a reduction in crime in the community when crime is increasing in other parts of the city. The recent hate crime at local Jewish institutions was committed by a troubled individual that lives in the district. He was released without bail and is awaiting a court date. The precinct is working diligently to remove abandoned vehicles from streets.

#### 4. REPORT FROM ASSEMBLY MEMBER JEFF DINOWITZ

Assembly Member Dinowitz informed residents that the legislature extended the rent eviction moratorium until the end of August. This extension protects people from evictions, mortgage foreclosures, and commercial properties. In the state budget several billions from the federal government was allocated to help tenants pay their rents to landlords. New legislation submitted by the Assembly Member would make the counterfeiting or forging of COVID-19 vaccination cards a serious crime. The Assembly Member thanked the NYPD for their response to the recent hate crime that occurred in the district. His office received reports of racing on the Henry Hudson Parkway. He will be reaching out to state police to address the problem.

#### 5. REPORT FROM COUNCIL MEMBER ERIC DINOWITZ

Council Member Dinowitz has joined several committees in the City Council including Aging, Education, Mental Health, Disabilities, and Addiction, Civil Services and Labor, Consumers Affairs, Small Business, Oversight and Investigations and Parks & Recreation. He also shared that he has co-sponsored a number of bills. He will work to secure funds for schools, parks, and mental health services. His office is conducting office hours throughout the district.

### 6. CHAIRPERSON'S REPORT – Laura Spalter

L. Spalter shared that she has sent a letter to all elected officials to push for an extension of the open meetings law to continue allowing community boards to meet remotely. The Community Board will partner with NYCHA on the Clean Streets event taking place at the Marble Hill Houses on May 29th. She also extended her condolences on the passing of former Deputy

Borough President Aurelia Greene. She congratulated S. Villaverde on being selected the Bronx recipient of the NYS Bar Associations Pro-Bono Service Award. She also informed the board that Donell Leverett has moved out of the district, thanked him for his years of service and wishes him well.

# 7. TREASURER'S REPORT – Diomarys Escano-Bell

D. Escaño-Bell provided an overview of the report and noted that we've allocated \$172,244 with \$76,424 remaining for FY2021. The board has no budget modifications. The board holds \$2,024 in encumbered funds.

#### 8. DISTRICT MANAGER'S REPORT - Ciara Gannon

- City Planning attended the last Executive Committee meeting to discuss the budget process which was very informative to many board members.
- The board is working closely with the Economic Development Committee on graffiti removal along Broadway and Marble Hill. This is possible with funds allocated by Council Member Rodriguez. We should be moving along with summer dates soon.
- A representative from the City Council attended the last Land Use meeting on behalf of Speaker Corey Johnson to discuss Intro 2186.
- The office is busy responding to resident complaints as we return to normal. The DM stressed the importance of calling 311 to log complaints. This helps with tracking local problems and is also required by all city agencies.
- Our new website is nearing completion with the help of T. Ochoteco and P. Romano.
- The office has started to order more office supplies which will be reflected in the next Treasurer's report.

#### 9. REPORT FROM DEPARTMENT OF CITY PLANNING – Not present

L. Daub conducted a Roll Call of Board Members and determined that a quorum was present.

#### 10. COMMITTEE REPORTS

#### a. YOUTH - J. Gomez

J. Gomez referred to the committee minutes. There won't be a May meeting due to a holiday conflict. The committee will have a meeting in June 2021.

#### b. AGING - L. Daub

A speaker from the Department of the Aging presented at the last committee meeting to share new programs. The committee does not plan to meet in June. .

#### c. BUDGET - D. Gellman

Every committee submitted their capital & expense budget priorities last month. A total of 44 capital priorities and 42 expense were submitted. D. Gellman will meet with the Chair & District Manager to review the list of priorities.

#### d. ECONOMIC DEVELOPMENT - N. Fazio

N. Fazio shared that the committee had an informative meeting which included the SBA Director, Silvia Rivera, who spoke about COVID recovery programs. The NYC Economic Development Corporation also presented. There was a walk-through of local businesses on West Kingsbridge Road. N. Fazio recognized the NYPD for their work on fighting graffiti. The next meeting is May 27<sup>th</sup>.

#### e. EDUCATION, LIBRARIES & CULTURAL AFFAIRS – S. Alexander

S. Alexander referred board members to the ELCA minutes for additional information. Mayor de Blasio has allocated funding to provide tutoring to help students catch up. Shelters should provide WiFi to students by August. The next meeting is on May 25<sup>th</sup>.

# g. HOUSING - T. Morris

T. Morris referred everybody to his minutes from April. He expressed his appreciation to elected officials for the extension of the eviction moratorium. The next meeting will be May 24<sup>th</sup>.

# h. LAND USE - M. Wolpoff

A presentation was given by the MTA and City Planning regarding a citywide text amendment that would include additional accessible train stations. Annie Levers of the City Council presented on Intro 2186.

**WHEREAS,** the NYC DOT proposes to paint a parking lane on the north side of West 254th Street between Mosholu Avenue and Riverdale Avenue;

**WHEREAS**, the NYC DOT proposes to paint bicycle sharrows on both sides of West 254th Street between Mosholu Avenue and Riverdale Avenue

**WHEREAS**, the NYC DOT proposes to paint a curb extension and install delineators on the northwest corner of Liebig Avenue and Mosholu Avenue.

**WHEREAS**, thirty-seven (37) merchants from Mosholu Avenue signed a petition in opposition to this plan;

WHEREAS, NYC DOT presented the same exact plan to this Committee in June 2019;

**WHEREAS,** in June 2019, when NYC DOT presented this plan, this Committee expressly cited that the most pressing condition on Mosholu Avenue dealt with north-south crossing of the street for pedestrians;

**WHEREAS,** NYC DOT has not put forth any changes to the north-south crossings of the street to make such crossing safer for pedestrians;

**BE IT RESOLVED THAT,** the Traffic and Transportation Committee rejects the NYC DOT Mosholu Avenue Traffic Calming plan.
