Chair Spalter convened the meeting at 6:35 PM and welcomed all to the Budget Hearing. Budget Chair, D. Gellman commenced the Public Hearing on Responses from City Agencies on the Capital and Expense Budget Priorities for FY 2023. The following community residents and stakeholders spoke in response to the budget priorities:

Tara McMaster spoke in support of an increase to the Parks Department Budget. Ms. McMaster supports additional funding for park maintenance and programming at Van Cortlandt Park. The Parks Department is understaffed and does not have enough equipment to do the important job they do.

Deirdre Burke spoke in support of additional funding for Parks, specifically staff, maintenance, and equipment. Ms. Burke also spoke in support of DOT maintenance such as: repaving, curb maintenance and sidewalk safety.

Calder Orr spoke in support of additional parks district staff, for park maintenance. He would also like to see an increase in park staff trainings and invasive species control at parks.

D. Gellman closed the budget hearing at 6:58 PM.

Chair Spalter convened the Full Board meeting at 7:00 PM. Chair Spalter called for a moment of silence for the people of Ukraine as they experience day thirteen of Russian aggression.

1. GALLERY SESSION:

Jodie Colon spoke in support of virtual meetings. When the Community Board resumes in person meetings, it is important for meetings to be hybrid.

Michael Greco (FDNY EMT & Paramedic Union) explained that FDNY EMS is making changes to the 911 system. Unit 27, stationed at W 234th St & Broadway, is being eliminated after ten years of service.

Leslie Hogan raised concerns about sewer back-ups between W 260th St & Mosholu Ave. on Broadway due to the recent storms. This has been an ongoing concern for residents who live on Broadway. Residents would like to see new storm water sewers along Broadway included in the Federal Infrastructure funding. New developments along Broadway add to these capacity concerns.

2. REPORT FROM The Bronx Borough President's Office- Ishrael Gonzalez

I. Gonzalez stated that all applications have been received for new board members. Board Members will be required to complete a sexual harassment training and once the link is available it will be sent out. There will be an Irish Heritage celebration at The Rambling House on Tuesday, March 15th.

3. REPORT FROM the 50th Precinct – Captain Florentino

Captain Florentino was recently assigned to the 50th Precinct. Year to date, there are 28 robberies, 103 grand larcenies and 45 grand theft automobiles. The Captain reminded residents not to leave valuables in cars and do not leave cars unattended. Concerns of tire theft and catalytic converters were discussed.

4. CHAIRPERSON'S REPORT - Chair Laura Spalter

Please see Executive Committee Minutes for a full report. Chair Spalter reported on a recent *New York Times* article regarding the African American Planning Commission and the proposed shelter at 6661 Broadway. The article focused on corruption, nepotism and fiduciary management concerns. Chair Spalter has written letters to the Department of Investigation,

Mayor Adams, local Elected Officials and she pointed out issues with the model, corruption, and lack of transparency.

5. TREASURER'S REPORT – Joyce Campbell Priveterre

Treasurer Joyce Campbell Priveterre went over the March Treasurer Report. The Budget report shows little to no changes. OMB has processed the December Budget modifications. There are no modifications for this month, but we expect a modification for next month and end of year spending. The Mayor's budget did not call for a Program to Eliminate the Gap (PEG) for Community Boards, meaning that the Community Board budget is not being cut this fiscal year. The office will be purchasing new equipment, software, furniture and supplies that can be used in a new office. All items must be purchased and received by June 30th, which is the end of the fiscal year.

6. DISTRICT MANAGER'S REPORT - Ciara Gannon

Please refer to the Executive Committee Minutes for a detailed report. Happy International Woman's Day & Woman's History Month. C. Gannon reported on hybrid meetings. The first priority is to secure physical locations for potential in person meetings. DM Gannon is fully committed to a hybrid model for meetings so that the public can observe meetings virtually. DM Gannon is exploring what other CBs are doing to prepare, speaking with DOITT, the Borough President's Office and outside tech professionals.

community to impact adversely on nature, character and residential design of the

C. Whereas Mayor Adams' preliminary budget actually allocates 0.5% of the proposed budget to parks, reducing the budget for the Department of Parks and Recreation from its current level, which will result in the loss of personnel in city parks; and

Whereas Mayor Eric Adams campaigned on a promise to allocate 1% of the New York City budget to The Department of Parks & Recreation; and

Whereas, Department of Parks and Recreation needs additional funding for operations and maintenance of parks and green spaces; and

Whereas when he was Brooklyn Borough President Mr. Adams recognized how vital the parks have been to New Yorkers during the pandemic, saying, "In the moments of this pandemic our green spaces provided a place for us to gather, express ourselves, and to simply catch a breath of fresh air"; and

Whereas all five borough presidents have endorsed the principle of 1% for parks; and

Whereas the City Council is holding hearings on the Mayor's proposed budget in March;

Therefore, Be It Resolved that Parks and Recreation Committee of the Bronx Community Board 8 calls on the City Council and our City Council Members, to hold Mayor Adams to his pledge to devote 1% of the budget to parks.
