Chair L. Spalter convened the meeting at 7:00 PM and welcomed all. She started the meeting with the presentation of the Comeback Kid Award, Betty Campbell Adams Most Valuable Merchant Award, and the Irving Ladimer Community Service Award. The Comeback Kid Award acknowledges youth in Community Centers who have overcome challenges and demonstrated improvement over a period of time. Youth Committee Chair, Julia Gomez presented this year's Comeback Kid Award to Michael Mack and Jasmine Pantajo.

Betty Campbell Adams owned Lloyd's Carrot Cake and was an outstanding business leader in CB8. The award honors the civic minded entrepreneurs in our community. Economic Development Committee Chair N. Fazio introduced the son of Betty Campbell Adams, Brandon Adams to deliver remarks to the honorees. The year's honorees were Laura Levine-Pinedo and Andre El-Saieh from Bronx Burger House, Eduvigis Marmolejos from One Yoga for All, Patti

Cassiere and Joe Sparacio from Cora's Hardware, and Jimmy Packes from Riverdale Auto Clinic, formerly Tigerdale Automotive which was presented posthumously.

Chair Spalter spoke briefly about Irving Ladimer, a long-time and dedicated member of Community Board 8. R. Jacklosky stated that the Irving Ladimer Community Service Award is given to recognize volunteer efforts in the community and inspire others to follow. The recipients are Danny Monge, Rita Freed, Julie Jenkins, Sara Allen, Selma Raven, and the Riverdale Y Jewish Community Center's Senior Volunteer Meals Program.

1. GALLERY SESSION:

Giovanni Puello – (Homeowner) - expressed opposition to the proposed combined housing and school development to be located at the former Visitation Church, located at 160 Van Cortlandt Park South.

Christina Carlson – (Homeowner, 180 Van Cortlandt Park S) - expressed deep concern over the proposed development plan for the former Visitation site, and to ask for a full public hearing on the matter, as questions of environmental impact, traffic, parking and public safety that have not been adequately addressed.

Hillary Bosch (DSNY) – Ms. Bosch shared information on the NYC Compost program which continues in Bronx Community Board 8. The program has now expanded into Queens. Residents can register online. Sign up at nvc.gov/curbsidecomposting. There is a delay in bin delivery. Any bin can be used until the new one is available.

2. REPORT FROM THE BRONX BOROUGH PRESIDENT OFFICE - NONE

3. REPORT FROM THE NYPD 50TH PRECINCT – CAPT. A. OSUNA

Captain Osuna stated that 50th precinct has seen a 47% increase in grand larcenies. The precinct has seen a decrease in rape/murder but an increase in burglary and grand larceny. The captain informed the board that the officers are working hard to keep the community safe.

4. CHAIRPERSON'S REPORT - L. SPALTER

Chair L. Spalter referred board members to the Executive Committee minutes for full report. She also expressed sadness at the passing of long-time board member Karen Pesce. Chair Spalter welcomed Lee Chong, Ingrid DeLeon, Rashida Hilliard, Scott Krompinger, and Leona Teten, as new members of Bronx Community Board 8. She asked new board members to briefly introduce themselves.

5. TREASURER'S REPORT – J. CAMPBELL PRIVETTERE – Absent due to family emergency. Treasurer report was provided at the Executive Committee meeting and sent to board in advance of meeting.

6. DISTRICT MANAGER'S REPORT - C. GANNON

C. Gannon welcomed Board members back from the summer recess. She informed the board that the Borough President's office will be having an orientation for new members. She expressed gratitude to Pablo Romano for helping with IT in preparation for the meeting. She stated that OTI (Office of Technology & Innovation) has hired a replacement for Joe Coluccio. Board Members were thanked for their participation in events such as Riverdale Pride, Family Day, National Night out, Marble Hill Block Party. BXCB8 will participate in the Job Fair organized by Council Member Dinowitz. Borough Budget Consultations have started, and the office will keep Committee Chairs updated with new information.

8. REPORT FROM ASSEMBLY MEMBER JEFF DINOWITZ

Assembly Member Dinowitz stated that his office organized paper shredding events throughout the district. He asked that residents support the proposals that will appear on their ballot. He encouraged residents to go online to read more on these proposals. The Assembly Member shared that he hoped a school would replace the vacant Visitation lot, however, he is not happy with the size of the proposed school.

9. REPORT FROM COUNCIL MEMBER ERIC DINOWITZ

Council Member Dinowitz congratulated new members to Community Board 8. The Council Member's office produces a newsletter every week and it's sent via email. He asked residents to sign up to get these interesting updates. (http://ericdinowitz.nvc/newsletter) His office is organizing a Job Fair on September 20 at Kingsbridge Library; Community Board 8 is a sponsor. He explained various legislations that he is sponsor/co-sponsoring in the City Council regarding 311. CM Dinowitz has allocated 5 million to Van Cortlandt Park.

a. Parks & Recreation - Bob Bender, Interim Chair

B. Bender stated that the next meeting is September 28 at the Van Cortlandt Golf House. He noted that he is only Interim Chair and urged board members to step up to fill the vacancy.

b. Public Safety - Edward Green, Chair

E. Green stated the next meeting is September 20th at the 50th Precinct. He shared that crime has increased in the district and encouraged members to consider signing up.

K. Buford stated the next meeting is September 15 at the St. Margaret's of Crotona School. L. Spalter shared that NYC DOT will attend to make a presentation on the Riverdale Ave Safety Improvement Plan and to answer questions on the recent implementation of the Riverdale Avenue redesign.

e. Aging – Lisa Daub, Chair
