Chair L. Spalter convened the meeting at 7:00 PM and welcomed all.

1. GALLERY SESSION:

 Marie Pierre Guiraud, of Catholic Guardian Services, stated that her organization is a nonprofit that provides health, creates hope and protects dignity through counseling, developmental disability services and family resources. They offer prenatal classes and parenting education classes for low-income parents in The Bronx. Classes are in person and once classes are completed a crib will be provided. Classes are provided in English and Spanish. For more information, please visit the <u>Catholic Guardian Services website.</u>

- Henry Morgan, NYC Mayor's Office- NYC Service announced several funding opportunities for local organizations. The first is NYC Civic Impact Funding which is given annually. There is \$200,000 for up to 20 different organizations. Requirements include: 501c3 or fiscal sponsor. Funds can be used for volunteer efforts. The second is Love Your Block Grant which is a mini grant for local community groups for neighborhood beautification projects. For more information visit NYC Service here.
- Gabriella Derasmo- NYC Parks Stewardship announced that there will be a forest restoration event at Riverdale Park on February 11th. Flyers will be shared with more details on this program.
- Joy Knight, Second Vice President & Chair of Scholarship Bronx Alumnae Chapter Delta Sigma Theta Sorority, Inc. provided information on a scholarship program for Bronx Students. Requirements include: HS students in five boroughs, 80 + average and going to a 4-year college or university in the fall. Must provide 2 letters of recommendations and a personal essay. Applications are to be mailed and postmarked by February 25, 2023. For more information please email Scholarship@dstbx.org
- Michael Zablauskas raised concerns about traffic issues at night on Broadway near the Yonkers Border. Cars are racing along Broadway because there is no lights or barriers for a good distance. The loud noise is disruptive to neighbors. The potential for accidents or hitting pedestrians is a major concern.

Bob Bender noted that this is a major issue in North Riverdale between the city line and the entrance and exit of the Henry Hudson Parkway. The 50th Pct needs to increase presence in this area. Ed Green noted that this issue has come before the Public Safety Committee Meeting and will continue to be addressed at committee meetings.

2. REPORT FROM THE BRONX BOROUGH PRESIDENT OFFICE - Alexis Ruiz

 Happy New Year. There will be a new online electronic Community Board application. Once it is available it will be sent out.

3. REPORT FROM THE 50th PRECINCT- Officer Cesar Sala

- For the 28 Day Period (this 28 day period compared to same period last year): 0 murder, Rape up from one to three. Robberies 11 % increase. Felony assaults increased from 9 to 15. Grand Larceny decreased from 45 to 44. Grand Larceny Auto decreased from 26 to 25. Overall there has been a 3.1 % increase in crime this period.
- Chair Spalter provided details on speeding on Broadway in North Riverdale and asked if the 50th Precinct will be getting more officers. There has been a lot of turn over at the precinct.
- Chair Spalter reported that she and District Manager Gannon were involved in interview process for new Commanding Officer for 50th Precinct. A new commanding officer has yet to be named.
- No Hate Crimes to report.

4. CHAIRPERSON'S REPORT – Laura Spalter

5. TREASURER'S REPORT – Scott Krompinger

- Borough President's Office is inputting bills until we hire a Community Coordinator. Cleaning bills and Zoom bills have been paid. The Riverdale Press has been paid for a job advertisement.
- A budget modification is expected next month
- We plan on purchasing a new door security system that will be reflected in the budget modification.
- There are carry over encumbrances that the District Manager is working on clearing up with FISA.
- Responded to questions asked at the last meeting. Zero dollars were spent in Telecommunications Equipment line because the city defines this line as telephones, fax machine, etc. Equipment is purchased under office equipment line. In June 2022 it was reported that there would be \$6K remaining but the number was higher because outreach material and promotional items wouldn't be fulfilled in time for June 30th. Order was not placed. Other WB Mason items were on back order and computer software was installed for free.

6. DISTRICT MANAGER'S REPORT - C. GANNON

- Provided information on proposed office door security system. Proposing purchase and installation of a video doorbell so that staff and members in conference room know who is at door. Current doorbell buzzers were damaged in the flood.
- Staff completed FMS training.
- Staff met with Office of Cannabis Management. A dispensary has been chosen in CB8. OCM will attend an upcoming Public Safety Committee Meeting and possibly an Economic Development Committee Meeting.

7. REPORT FROM DEPARTMENT OF CITY PLANNING - No Report

 Chair Spalter reported that Camila Thomas will attend the Land Use Committee meeting on Thursday.

8. REPORT FROM COUNCIL MEMBER ERIC DINOWITZ

- Working with CB8 & elected officials with DHS regarding proposed shelter at 6661 Broadway. A joint letter went to DHS regarding the process and proposal.
- Reported on proposed charter school on W 232nd Street. There was a meeting
 with the elected officials, building coop boards and the developer. Waiting on
 answers from the school.
- Advocating for NYC retiree healthcare.
- It is budget season. Discretionary funding applications is open. There will be a training next week on applying for discretionary funding.

9. REPORT FROM ASSEMBLY MEMBER JEFF DINOWITZ

- Responded to complaints about speeding on Broadway and is advocating for increase of speed cameras throughout the city.
- Charter Schools do not require the same amount of city oversight. His office is working on getting updates on the charter school in Kingsbridge.
- Longtime advocate for public access to the Jerome Park Reservoir.
- Provided update on State of the State & legislative update.

10. REPORT FROM SENATOR GUSTAVO RIVERA

- Reported on new senate district. Will represent all of Riverdale.
- Provided brief update on State of the State. A lot of work needs to be done.
- In solidarity with Nurses on strike.
- Focusing on housing in Albany. 421 A expired and looking forward to working on a fair incentive for developers.
- Cannot support proposed shelter on Broadway. Does not support current model or process the city took with the community.

- Senator Jackson now represents Marble Hill, parts of Kingsbridge Heights, Van Cortlandt Village and parts of Riverdale.
- Chair & DM met with Senator Jackson and will continue to work with him on the areas he represents and on budget requests.

WHEREAS, the CB8 Environment and Sanitation Committee (E&S) reviewed the United States Army Corps of Engineers (USACE) New York New Jersey Harbor and Tributaries Study Tier 1 Feasibility Study (NYNJHATS) available at https://www.nan.usace.army.mil/Missions/Civil-Works/Projects-in-New-York/New-York-New-Jersey-Harbor-Tributaries-Focus-Area-Feasibility-Study/, and its impacts on the Bronx Community Board 8 district;

WHEREAS, the CB8 E&S Committee "Water Working Group" submitted a report on the feasibility study to the E&S committee on January 3, 2023 for consideration by the committee:

WHEREAS, the main concerns of the CB8 E&S Committee relate to the possibility of the proposed changes in the Manhattan harbor area to direct more water north, impacting Bronx CB8 district, potentially increasing pressure against the outbound water from combined sewer overflow (CSO) outfalls and simultaneously exacerbating existing storm surge flooding patterns and conditions;

WHEREAS, the main recommendation from the Bronx CB8 E&S Committee is for USACE to study the impact of the additional water volume on the northern bank of the Harlem River, and to mitigate against stormwater backups in the Northwest Bronx;

THEREFORE BE IT RESOLVED, that Bronx CB8 approves the "Bronx Community Board 8 Comments on the NYNYHATS Tier 1 Feasibility Study", as its comment on the study.
