Karen Argenti, of Bronx Council of Environmental Quality (BCEQ), announced that the Bronx Speak Up event will be held in person on Saturday February 25<sup>th</sup> at Lehman College. Deirdre Burke raised concerns about unintended consequences of DOT projects throughout the city. The response time for emergency vehicles has been prolonged. School buses are getting to school late. DOT projects may be slowing traffic and in turn causing safety issues throughout the city.

❖ WHEREAS, Maria De La Cruz, Representative of Kalle Bar & Grill, located at 3638 Baily Avenue, appeared before the Public Safety Committee on November 15<sup>th</sup>, 2022 to apply for an alteration to the establishment.

**WHEREAS**, at the September 20<sup>th</sup> Public Safety Committee meeting, 50<sup>th</sup> Precinct Representatives stated they had received multiple 311 complaints for noise, double parking, and other quality of life disturbances at the location of this establishment.

**WHEREAS**, Bronx Community Board 8 has since received a written statement from the Representatives of Kalle Bar & Grill detailing measures they have taken to address the areas of concern.

❖ WHEREAS, a Representative of Tijuana Nites, located at 216 West 242<sup>nd</sup> Street, failed to appear before the Public Safety Committee on November 15<sup>th</sup>, 2022 to renew this establishment's liquor license and apply for a corporate change.

**WHEREAS**, Representatives of NYPD's 50th Precinct stated that, over the years, they've received many complaints about noise, parking violations and various other disturbances at this establishment and frequent complaints continue to this day.

**WHEREAS**, Assemblyman Dinowitz's office notified Bronx Community Board 8 of various constituent complaints and provided a lengthy list of 311 complaints against this establishment in 2022.

**WHEREAS**, Assemblyman Dinowitz's office sent an inquiry to the Department of Health about this establishment and several violations were found.

WHEREAS, a resident of 216 West 242<sup>nd</sup> Street stated Tijuana Nites caused frequent disturbances, and cited public drunkenness and drug use outside the club, harassment of building residents by the club's patrons and loud music that disturbs sleeping residents until 4am; he also stated he was concerned for the welfare of his wife and child because he suffered a broken jaw due to being assaulted by employees of the club.

**WHEREAS**, 216 West 242<sup>nd</sup> Street was previously occupied by an establishment called Barcelona Bites, which had the same Owner and Representative as Tijuana Nites and had a corporate change disapproved by the State Liquor Authority in 2019 for failing to provide required information about Principals of the transaction.

**WHEREAS**, the Public Safety Committee has seen no attempt by this establishment to accommodate area residents and address the well documented history of complaints against them.

**WHEREAS**, the Public Safety Committee unanimously disapproved this application.

**THEREFORE, BE IT RESOLVED**, Bronx Community Board 8 disapproves this application.

## m. Traffic & Transportation- Kelli Buford

 DOT attended the November meeting and presented a carshare proposal for the district. The next meeting will be January 19<sup>th</sup>. The following resolution was discussed: WHEREAS, the New York City Department of Transportation (DOT) first presented its Permanent Carshare Program to the Traffic and Transportation Committee on November 17, 2022;

WHEREAS, DOT stated that it would give Bronx Community Board 8 only 30 days for comment on the Permanent Carshare Program;

WHEREAS, Traffic and Transportation Chair Buford and Community Board 8 Chair Spalter asked that DOT give the Community Board 90 days to comment on the Permanent Carshare Program;

WHEREAS, DOT stated that they would get back to Community Board 8 on whether they will permit comments beyond the 30-day period;

WHEREAS, this is an interesting yet complicated proposal;

WHEREAS, Community Board 8 wishes to have a meaningful, merit-based discussion on the proposed Permanent Carshare Program with an opportunity to investigate the locations, inform the public and elicit testimony from the Community District;

THEREFORE, BE IT RESOLVED that Bronx Community Board 8 rejects the Permanent Carshare Program locations in Community Board 8 based upon a failure of DOT to give Community Board 8 adequate time to review the proposal, especially given the fact that the presentation was not given to the Community Board to review the details prior to the November 17, 2022 Traffic and Transportation meeting.
