Chair L. Spalter convened the meeting at 7:00 PM.

1. GALLERY SESSION:

- Xiomara Loarte, Community Outreach Coordinator, Central Labor Council, provided an introduction to work and mission of the Central Labor Council
- Joan Byrnes, Director, Bureau of Community Affairs, NYC Department of Sanitation, explained the waste set-out time change which will go into effect on April 1st

- Carlos Torres, Crime Prevention Coordinator, Office of the Bronx District
 Attorney Darcel D. Clark spoke about a Child Safety Fair which will occur on April 15th and a Resource Fair which will occur on April 19th
- Seth Kaplan, Owner, P&K Grille Inc., spoke about his business and the recent lapse in their liquor license renewal and thank the Board for its support
- Shanel Goring, Community Manager, Office of NYC Council Member Pierina Sanchez, provided information regarding their office hours and a Community Wellness Fair, Monday March 20th

2. CHAIRPERSON'S REPORT – Laura Spalter

- Made motion to add a real estate resolution to the agenda, Board Member D. Gellman seconded the motion. No opposition or abstentions noted. Motion passed.
- Provided information on the street renaming ceremony commemorating Bill Stone. The ceremony will occur on Sunday May 7th at 11:00am at the intersection of Hudson Manor Terrace and West 237th Street, Bronx, NY. Noted that there will be April meeting date changes due to the holidays.
- Announced the nomination period is slated to begin for the Irving Ladimer Community Service Award and Betty Campbell Adams' Most Valuable Merchant Award. Thus far, the Ad Hoc Irving Ladimer Community Service Award Committee includes C. Calhoun and L. Teten.
- Discussed new developments and concerns with the City's homeless services contract for a site at 6661 Broadway, Bronx including the following:
 - 1. The NYC Department of Homeless Services has entered into a contract with a new provider, Westhab, Inc. for approximately \$355 million
 - 2. The status of the contract is "in progress" meaning that the contract hasn't yet been received by the Comptroller's office, thus the 30-day public comment period has not yet begun.
 - 3. On March 5th, 2023 NY Post did an expose on the family relationship between a vice president at Westhab, Inc. and a senior administrator at the Department of Homeless Services.
 - 4. L. Spalter spoke with Queens Council Member R. Holder whose district has a Westhab, Inc. homeless shelter, as well as the local district manager for Queens Community Board 5. Details of health and public safety concerns associated with the shelter there were confirmed.
 - 5. L. Spalter noted that because time is of the essence she sent letters to the Bronx District Attorney's office and participated in a joint letter with Assembly Member Dinowitz and Council Member Dinowitz to the Mayor's Office (cc'ing COIB and MOCS) to illuminate potential improprieties including conflict of interest in the handling of this contract.
 - 6. Noted that there are two businesses renting commercial units at 6661 Broadway who are fighting an eviction notice. The property remains in contract and will be sold once it has been vacated.

- M. Wolpoff asked whether the City will own the 6661 Broadway property at the end of the contract. L. Spalter noted that there are several LLCs that have been established to buy this building.
- L. Spalter confirmed that a letter has been sent to the Mayor's Office of Contract Services. D. Padernacht noted that the City is likely able to change the operator. D. Padernacht stressed the need for a copy of the contract and sections applicable to the City's ability to change the operator.

- Answered a question from M. Joyce regarding Inflation Reduction Act grant opportunities

Land Use- C. Moerdler

- Spoke about the impact of the DOB's Homeowner Relief Program on Special Natural Area District (SNAD) enforcement, a recent resolution from the board about SNAD, and potential litigation that may ensue
- Noted that the board office had received notifications on Landmark Preservation Commission applications in Fieldston and that the committee may review
- Noted that on April 3rd meeting the Committee will take up a report and revised resolution on affordable housing with the expectation that the Department of City Planning will soon present text amendments to the committee on this topic
- Noted that Chair Moerdler will not preside over a discussion on the Visitation site at an upcoming meeting

Law, Rules & Ethics – Martin Wolpoff

- Discussed the construction project of 3745 Riverdale Avenue, as it relates to the Land Use Committee report
- Highlighted pending legislation proposed at the NYC Council
- Member C. Moerdler asked whether anyone on the board had an objection to the Land Use Committee looking into a housing development occurring in Yonkers near the CB8 border. No objections noted. D. Travis noted concerns that the housing development may cause shadows and construction impacts on Van Cortlandt Park.

Parks & Recreation – Deb Travis

 Discussed a proposed resolution in support of the installation of a pickleball court in Riverdale Playground. Here is the resolution:

Resolution in Support of Pickleball Court Installation in Riverdale Playground

WHEREAS, representatives from the Department of Parks and Recreation (DPR) met with the Parks & Recreation Committee of Bronx Community Board 8 on February 22, 2023, and presented plans for installing a single pickleball court on the site of two existing handball courts in Riverdale Playground;

WHEREAS, the new configuration would leave two remaining handball courts for community use;

WHEREAS, DPR representatives answered questions from committee members and from members of the public who attended the meeting to the general satisfaction of the committee members; THEREFORE BE IT RESOLVED, that Bronx Community Board 8 approves the plan for installing the pickleball court as presented to the committee with the understanding that DPR will return to the committee for further discussion if there are any substantive alterations to the plan that was presented.

WHEREAS, Michelle Rossetti and Mindy Birnbaum, Representatives of Great Performances/Artists as Waitresses, Inc., located at 675 West 252nd Street, appeared before the Public Safety Committee on February 21st, 2023 to renew this establishment's liquor license. WHEREAS, Representatives of NYPD's 50th Precinct stated they were unaware of any prior notable disturbances or complaints at the location of this establishment. WHEREAS, a 2AM agreement was signed by the establishment's owner and received by the Board. Therefore, BE IT RESOLVED, Bronx Community Board 8 approves this application.

WHEREAS, the NYS liquor license of P&K's Grille Inc., located at 170-174 West 231st Street expired on 2/28/23.

WHEREAS, Seth Kaplan, Owner of P&K's Grille Inc., states he had not received the SLA advisory notice for his renewal.

WHEREAS, a Representative of the State Liquor Authority stated the agency would grant P&K's Grille Inc. an extension before their application was reviewed, on the condition that Bronx Community Board 8 issue them a waiver of the 30-day notice.

WHEREAS, Seth Kaplan of P&K's Grille Inc., has requested a waiver of the remainder of the 30-day notice to appear before the Public Safety Committee so he can file a renewal application for a liquor, wine, beer & cider license with SLA.

WHEREAS, Assemblyman Jeffrey Dinowitz and Councilman Eric Dinowitz have written the State Liquor Authority requesting the SLA renewal for P&K's Grill, Inc. be expedited.

WHEREAS, Seth Kaplan has agreed to attend the March 21st Public Safety Committee Meeting to have his SLA application reviewed.

WHEREAS, Representatives of the 50th Precinct stated there have been no notable complaints or reports of disturbances at P&K's Grille Inc., located at 170-174 West 231st St.

THEREFORE, **BE IT RESOLVED**, Bronx Community Board 8 supports a waiver of the remainder of the 30-day notification requirement and the renewal of P&K's Grille Inc. (Serial # 1004693) liquor license.

Wolpoff made a friendly amendment to change the resolution's wording from "therefore be it resolved that, the Traffic & Transportation Committee" to "therefore be it resolved that, Bronx Community Board 8:"

SAPO Application: Riverdale Y Sunday Market (April 2)

WHEREAS, the Riverdale YMHA presented its intent to operate a one-time pop-up farmers market on Johnson Avenue on Sunday, April 2, 2023 from 7am – 3pm; and

WHEREAS, the applicant will maintain a 15-Foot emergency lane through the center; and

WHEREAS, the Riverdale YMHA held a similar event in May 2022; and

WHEREAS, the pop-up market has received favorable feedback from the community in support of the issuance of a full street closure permit to allow the event to occur;

THEREFORE BE IT RESOLVED THAT, Bronx Community Board 8 supports the issuance of a permit to the Riverdale Y Sunday Market for the full street closure on Sunday, April 2, 2023 on Johnson Avenue between West 235th Street and West 236th Street for the sole purpose of operating a one-time pop-up farmers market.

- The committee brought forward a resolution to rename a crosswalk at 6115 Broadway "Betty and Lloyd Adams Way:"

Request for Street Renaming near 6087 Broadway in Honor of Betty and Lloyd Adams of Lloyd's Carrot Cake Bakery

WHEREAS, Betty Campbell-Adams and Lloyd Adams have been nominated for the honor of this proposed street naming by the Riverdale Neighborhood House, Riverdale Main Streets Alliance and the Kiwanis Club of Riverdale, which are three community organizations active in Bronx Community Board No. 8 that are on the list required to be kept by Bronx Community Board No. 8 under the City Charter; and

WHEREAS, Betty Campbell-Adams and Lloyd Adams opened Lloyd's Carrot Cake across the street from Van Cortlandt Park in Bronx Community Board No. 8 in 1986 and it quickly became a staple in this community; and

WHEREAS, the evidence and testimony presented to Bronx Community Board No. 8 has demonstrated that Betty Campbell-Adams and Lloyd Adams were vibrant members of our community, often donating their time and money to local charitable organizations; and

WHEREAS, Betty Campbell-Adams served on several local boards including the Child Welfare Organizing Project, Kingsbridge Riverdale Van Cortlandt Development Corporation and Riverdale Main Street Alliance; and

WHEREAS, Betty Campbell-Adams and Lloyd Adams were examples of neighborhood business owners who gave back to the community to make it a better place; and

WHEREAS, Bronx Community Board No. 8 established the Betty Campbell-Adams Most Valuable Merchant Award to honor the many contributions Mrs. Campbell-Adams made to the community; and

WHEREAS, the evidence and testimony presented to Bronx Community Board No. 8 has demonstrated that Betty Campbell-Adams and Lloyd Adams have benefited a cross-section of Bronx Community District No. 8 and the Borough of the Bronx and the City of New York; and

WHEREAS, this location has a specific connection to Betty Campbell-Adams and Lloyd Adams as it is in proximity to Lloyd's Carrot Cake, the business founded by Betty Campbell-Adams and Lloyd Adams; and

WHEREAS, Betty Campbell-Adams died on December 11, 2020 and Lloyd Adams died on February 1, 2007 and this resolution is brought more than two years after their deaths; and

WHEREAS, the name change will not engender confusion as there are no other streets with similar name in the vicinity;

THEREFORE, BE IT RESOLVED, that the traffic-light controlled, east-west crosswalk located at 6115 Broadway between West 251st Street and Manhattan College Parkway be named **Betty and Lloyd Adams Way.**

- L. Spalter read aloud a letter from September 2017 that was written by former chair R. Ginty to elected officials regarding criteria for ideal locations of a Board Office in Kingsbridge.

- C. Tepelus made a motion, pending the chair allowing other board members to speak, to close the discussion and move on to a vote on a resolution
- B. Fanuzzi made a friendly amendment to add the following to the resolution: "be
 it further resolved that DCAS should continue working with the Board to seek
 additional sites." The amendment was adopted without any opposition. The final
 wording of the resolution is as follows:

BE IT RESOLVED, in the matter of a new Board Office, Bronx Community Board 8 approves the Department of Citywide Administrative Services (DCAS) continuing its negotiations with the landlord of the site under discussion, which began on January 5, 2023.

BE IT FURTHER RESOLVED that DCAS should continue working with the Board to seek additional sites.
