Report from the Borough President's Office

Report from the 50th Precinct

Robberies up 22%. Grand larceny is a problem up 18% in the 50th Precinct and throughout the whole City (people leaving valuable items in cars, rims/tires Hondas and KIAs), officer assaulted on 1 train (perpetrators caught and being processed by the Bronx DA's office), CB8 Zoom 'bombings' being investigated as hate crimes, NYPD enforcing no scooters on sidewalks. The Board requests they make sure monthly hate crime reports are included in the monthly report. NYPD closed Illegal smoke shop on 225th. The process is lengthy but trying to stay on top of illegal shops.

Report from the Mayor's Office

The mayor has released a plan on Artificial Intelligence. The mayor is working with corporate council to crack down on shops selling vapes, Mayor is working with TLC Commissioner to deliver on zero emissions and wheelchair accessible by 2030. The mayor with Governor Hochul announced \$300m for bioresearch. The mayor with DOT Commissioner working to advance dining out NYC to help restaurants maintain outdoor dining, wants people to report if businesses are not following trash guidelines, announced new channel on WhatsApp, and reminding public that 'text to Eric' is available.

Sen Jackson is seeking for introduced bills to be passed. He is working with Gov. Hochul. Contact jackson@nysenate.gov to be added to his email list.

Senator Rivera held walk and talk with District Manager, Chairperson, and community residents and merchants reviewing issues of importance in the district. Bronx Community Board 8 Resolution to support and advocate on behalf of the New York City (NYC) Municipal Retirees and urging the New York City Council to pass Intro. 1099-2023, which will preserve retiree health care choices by mandating the City to offer Medicare-eligible City retirees and their Medicare-eligible dependents at least one Medigap plan with benefits equivalent to or better than those available to City retirees and their dependents as of December 31, 2021.

WHEREAS, so many constituents have served the New York City (City) and are now enjoying the retirement benefits they earned, and;

WHEREAS, the issue of healthcare is extremely important and must be protected for the 250,000 NYC retirees who worked for their healthcare rights, and;

WHEREAS, Intro. 1099-2023 is in the Civil Service and Labor Committee in the New York City Council (Council) and awaits a hearing so it can move forward in the Council, and;

WHEREAS, the NYC retirees are being forced into a Medicare Advantage Plan (MAP) with no alternative option provided, and;

whereas, this plan threatens retirees' access to the level of health care they have received in the past, in that retirees would be forced into a MAP with limited medical providers and would also be at the MAP's whims for preauthorization decisions that may be based - at least in part - on Artificial Intelligence - instead of the medical decisions from their current regular medical providers, and;

WHEREAS, the proposed plan would draw millions of dollars away from traditional Medicare into a privatized MAP, and;

WHEREAS, the proposed plan sets a harmful precedent for the rest of the Nation, and;

whereas, the NYC Retirees have testified in various forums, including at the January 11, 2023, NYC Council Civil Service and the Labor Committee public hearing, that they have been subjected to unconscionable stress due to this violation of their earned healthcare benefits, and;

WHEREAS, the Bronx Community Board Aging Committee unanimously supported this draft resolution at its October 12, 2023, meeting.

NOW, THEREFORE, BE IT RESOLVED,-Bronx Community Board 8 urges all of its elected officials to publicly support the NYC Organization of Public Service Retirees' efforts to enact Intro. 1099-2023. We request that the City maintain the choice of the original Medicare plan and a Medigap plan provided at the time of employees' hiring, and not force retirees into a private, profit-driven healthcare plan, and;

BE IT FURTHER RESOLVED, we urge Council Members Eric Dinowitz, Carmen De La Rosa, and Pierina Ana Sanchez to uphold the City's obligations to its retirees, including its obligations set forth in New York Administrative Code §12-126. Consistent with these obligations, the City has for several decades (since 1967) paid the out-of-pocket cost of the GHI Senior Care plan, a Medigap plan which the majority of NYC Retirees have chosen; and;

BE IT FURTHER RESOLVED, we urge the New York City Council to exercise leadership by bringing the vote to the floor for membership to vote to enact Intro. 1099-2023.

VAN CORTLANDT MOTEL-SCHOOL SITE RESOLUTION - OCTOBER 24. 2023

WHEREAS, on October 3, 2023 the School Construction Authority notified Bronx Community Board No. 8 that Pursuant to section 1731 of the New York City School Construction Authority Act notice that a proposed site selection of Block 5841, Lots 1968, 1978 and 1988, located in the Borough of the Bronx, for the construction of a new, approximately 547-seat Primary School in Community School District No. 10, including a statutory due date of November 21,2023 for submitting comment, and;

WHEREAS, the proposed site is located at 6389-6393 Broadway on the southwest corner of the intersection of Broadway and West 256th Street in the Riverdale neighborhood of the Bronx. The site is currently occupied by a two-story motel with accessory parking. The proposed site to be acquired by the New York City School Construction Authority, on behalf of the New York City Department of Education, is an approximately 32,675 square feet (0.75 acre) lot, and;

WHEREAS, the proposed citywide zoning changes in "City of Yes" will facilitate development opportunities for affordable housing and increase our student population, and;

WHEREAS, new state law mandating smaller class size necessitates construction of additional schools or face losing current specialized rooms for music, art, science, and libraries, and;

WHEREAS, the proposed local sites for housing migrant families (such as Stagg's Waldo Avenue/West 238 Street dormitory) will continue to increase our school population, and;

WHEREAS, the NYS School Construction Authority Act, Section 1731, paragraph #3 states: Within forty-five days after publication of such notice, each affected community school board or community board shall prepare and submit to the authority, written comments on the site plan...... Each comment received by the authority on such plan at the time prior to action being taken by the authority in connection with such action.

NOW, THEREFORE, BE IT RESOLVED, that the Bronx Community Board 8, Community Residents and Education, Libraries & Cultural Committee (ELCA) shall prepare written comments on site plan as received at October 24,2023 Public Hearing prior to forty-five days limit (i.e., November 2023)

BE IT FURTHER RESOLVED, that Bronx Community Board 8 be allowed to comment on the findings discovered through the State Environmental Quality Review (SEQR) before issue goes to City Council for a vote, and

BE IT FURTHER RESOLVED, that the School Construction Authority returns to Bronx Community Board 8 at the earliest possible time with a site plan including design and operational details and information not available at this time.

BE IT FURTHER RESOLVED, that Bronx Community Board 8 and Education, Libraries & Cultural Affairs Committee believe that after all other requirements are acknowledged, the Van Cortland Motel site is an appropriate site for a primary school.
