The meeting was called to order at 7:35PM.

The minutes of October 24,2023 were approved as written.

The Chairperson introduced Dr. Christina Carlson to speak about the proposed school site at the former Visitation Church. Dr. Carlson and other residents in her building had brought an article 78 legal action against the School Construction Authority (SCA) and New York City Council for accepting the "Environmental Negative Declaration" instead of doing an "Environmental Impact Statement" (EIS). The New York State Supreme Court Judge just ruled that the action of SCA and the New York City Council was "arbitrary and capricious" and an EIS must be done.

Dr. Carlson and the residents won their case. The decision might be appealed by SCA/NYC. The committee

thanked Dr. Carlson for taking the time to address the issue with us. This information will be helpful when

environmental issues arise with the next proposed primary school site at Van Cortlandt Motel and as the SCA

advances an EIS for the Visitation site, as ordered by the court decision.

The Chair called on libraries for their reports. There were four branches represented. Please check your branch

library, on their websites, for many interesting programs available for all ages. Library calendars are also

available on our website, to inform the community when the programs will occur.

The committee has requested site visits to schools in Community Board No. 8 and the Chair will contact the

schools, as to their availability.

The meeting was adjourned at 9:00PM.
