LAW, RULES & ETHICS COMMITTEE RESOLUTION – ADA

June 26th, 2024

WHEREAS, Bronx Community Board 8 at its May 2024 regular monthly meeting, voted to end the practice of permitting for Extraordinary Circumstances (EC) to enable some Board members to participate in Bronx Community Board 8 meetings via telecommunications, and,

WHEREAS, Bronx Community Board 8, in eliminating EC, voted to continue to provide persons covered under the Americans with Disability Act (ADA) access to meetings through videoconferencing with the recognition that such persons be counted toward the quorum, and

WHEREAS, §1647-A has been introduced in the New York State Senate proposing that a quorum for community boards as found in the NYS Open Meetings Law (POL § 103- a(2)(c)) be reduced from a majority to one quarter of its membership, and

WHEREAS, the members of Bronx Community Board 8 believe that votes on matters of community concern should require at least the majority of a full quorum,

THEREFORE, BE IT RESOLVED, that Bronx Community Board 8 requests that the New York State Senate and New York State Assembly, should it be introduced there, reject the proposed amendment.

RESOLUTION June 4th, 2024

WHEREAS, the terms "Affordable Housing", "Area Median Income" or "AMI" as currently applied and defined in laws applicable to the City of New York are frequently predicated on data from a geographic area that includes New York

City suburbs and are not representative of the city itself, and for that reason contribute to the lack of housing truly affordable for residents of New York City, particularly the Bronx, and

WHEREAS, affordable housing is a perennial high priority for the Community Board 8 District Needs Statement, as it is for many other community boards in New York City,

WHEREAS, the Land Use Committee of Community Board 8, Bronx proposes the following resolution:

THEREFORE, Bronx Community Board 8 proposes the following resolution:

COMMUNITY BOARD NO. 8, BRONX COUNTY, CALLS UPON THE CITY COUNCIL MEMBERS REPRESENTING ANY PORTION OF THE COMMUNITY BOARD DISTRICT TO PROPOSE AND THE CITY COUNCIL TO ENACT WITH ALL DELIBERATE SPEED LEGISLATION

- 1. Defining the term "Affordable Housing" as applied to any relevant law, ordinance or regulation or the interpretation or application thereof in and by the City of New York mandating that such definition be predicated solely upon data derived from the five Counties comprising the City of New York; and
- 2. Defining the terms "Area Median Income" and/or "AMI" predicated solely upon data derived from and pertaining to (a) the City of New York or the five Counties comprising the City of New York or the New York City postal zip codes and that such definition be applied to any applicable law, ordinance, regulation or the interpretation or application thereof in and by the City of New York and any instrumentality thereof.

To be clear, the purpose of the foregoing is to limit the data used in defining the foregoing terms to such data as is derived exclusively from applicable New York City predicates.

3. This definition and its application shall be construed in conjunction with any existing federal regulation.

WHEREAS the Committee has received, reviewed and commented upon drafts of and a final proposed Committee Report, a copy of which is attached hereto and made part hereof, together with annexed appendices; and

WHEREAS after due consideration it is hereby

THEREFORE, BE IT RESOLVED that the Special Committee on City of YES—Housing Opportunity

- 1. Rejects the City of Yes for Housing Opportunity Proposal and finds it lacking in supportive merit and fatally flawed:
- 2. Urges Bronx Community Board No. 8 to likewise accept and promulgate to the appropriate persons and entities the attached Report and its Appendices;
- 3. Calls upon the Members of the New York City Council representing any segment of the population within the Bronx Community Board 8 District to categorically reject the Proposal;
- 4. Urges the New York City Council to reject the Proposal in its entirety as contrary to the public interest.
