#### **FY25 Public Budget Hearing**

Budget Committee Chair D. Gellman outlined the budget process according to the City Charter.

Comments from Members of the Community:

- Community member is advocating for the Bruckner Box in the Expense Budget for the Henry Hudson Park.
- With the 15% budget cuts coming forward, community members is advocating for additional funding to the NYC Parks Department.
- Senator Robert Jackson's Office states that if there is an organization in the district requesting capital funding for a project over \$35,000, reach out to their office.

The Budget Public Hearing was closed at 6:47 p.m.

Chairperson J. Reyes convened the Full Board meeting at 7:09 PM and announced committee members approved for extraordinary circumstances (EC).

Chairperson J. Reyes asked for a moment of silence for the victims of the October 7 attacks in Israel.

# Report from NYS Assemblymember (AM) Jeffrey Dinowitz

AM Dinowitz is proud to live in a community where hundreds of people can come together for a prayer vigil. The worst massacre of Jews since the Holocaust. The reaction by some groups in our country is shocking where people were celebrating the attacks. Tough times ahead. Competing rallies in Riverdale regarding a possible migrant residence on W. 238<sup>th</sup> Street and Waldo Ave. The building should be used for permanent affordable housing. People from outside of the community were being divisive and turned into a partisan event. Sponsoring shred days throughout the district. Proud of the community coming together to oppose the cricket proposal during the summer at Van Cortlandt Park.

# Report from the NYPD 50th Precinct

Special Ops Lieutenant Baez read the crime statistics for the year to date. 4 murders in 2023. 8 rapes in 2023 compared to 15 rapes in 2022 (decrease in 46%). 120 robberies in 2023 compared to 147 robberies in 2022 (decrease in 18%). Down 3% in felony assaults. Burglaries have increased (114 v. 104). Grand larcenies have decreased 2.3%. The biggest issue in the 50<sup>th</sup> Precinct are the grand larceny autos (GLA) which have increased by 31%.

# Report from NYC Councilman (CM) Eric Dinowitz

Encourages the public to follow him on social media and twitter where statements are being put out regarding the October 7 attacks in Israel. Condemns the Hamas attack on innocent civilians in Israel. Working with colleagues to understand the implications of the rallies that celebrate the attacks. Working with city agencies, NYPD, the Department of Education and CUNY to make sure that everyone has the resources, and everyone feels safe. Introduced legislation requiring there be emergency response centers in the case of fires. A number of quality-of-life issues and mismanagement in Godwin Terrace but worked with West Bronx Housing to knock on doors and organize a tenant's association and let them know of their rights.

# Report from NYS Senator Gustavo Rivera

New part of the district for Senator Rivera. Spoke on the illegal cannabis dispensaries in the district and if you identify any illegal dispensaries, let the office know. The office remains at 2432 Grand Concourse, Bronx, NY 10458 and satellite office hours are available at Riverdal Senior Services (RSS). Immigration and legal services are also available. Be in touch with the office for more information.

# Report from the Mayor's Office

Prayers and condolences to the people who lost loved ones on the October 7 attacks in Israel. The Mayor and Sanitation Commissioner have announced the next phase on the war on rats, and this includes all businesses that must put their trash out in containers. If you notice a business is not in compliance, please reach out to 311. The Mayor has announced a partnership to create green jobs, provide workforce training and electrify vehicles. As the number of asylum seekers increase, the Mayor announced a 30-day notice for adult migrants to work with their case workers to take the next step. The Mayor launched the City of Yes for Housing Opportunity. New Yorkers with CityFHEPS will be able to find permanent affordable housing within New York State, not just New York City. The Mayor announced \$15 million in federal funding to plant and maintain city trees. The Mayor and the HPD Commissioner have taken actions to connect New Yorkers to affordable housing more quickly (no credit checks). The Mayor concluded a two-day summit on fentanyl.

# Report from U.S. Congressmember Ritchie Torres' Office

Congressmember Torres is in solidarity with the Jewish people and a very strong supporter of Israel. If anyone has any federal issues, please reach out to the office for assistance. Congressman Torres introduced a bill (H.R.5518) – the Right to Medicare Act. This bill, if passed, would allow each participant in Medicare to select if they want regular Medicare or Medicare Advantage.

- a) <u>Land Use</u> The next Land Use Committee meeting is on October 18, 2023. Various Special Natural Area District (SNAD) applications will be discussed and voted on during the meeting. The Stagg purchase of 3801 Waldo Avenue will also be discussed at the meeting.
- **b)** Law, Rules & Ethics The next Law, Rules & Ethics Committee meeting is on October 23, 2023. Looking into the Open Meetings Law (OML) regarding the use of Extraordinary Circumstances (EC). Sent all board members the copy of the Conflicts of Interest Board (COIB) Plain Language Guide. Concern expressed over the use/abuse of abstentions.

c) Parks & Recreation – On September 20, 2023, the International Cricket Council informed us they will not be hosting the Cricket World Cup at Van Cortlandt Park. Thanked all who played a role in supporting the maintenance of the public space. The next meeting is October 25, 2023. The developer of 55 Dash Place has paved a portion of a mapped, but unbuilt, street that is adjacent to Brust Park. As such, D. Travis presented the below resolution:

**WHEREAS,** West 242nd Street between Dash Place and Waldo Avenue is a mapped, but unbuilt, New York City street adjacent to Brust Park on the north side and 55 Dash Place and 3875 Waldo Avenue on the south;

**WHEREAS,** the community, including the owners of 3875 Waldo Avenue and Stewards of Brust Park, have expressed concern on numerous occasions that a hazard would be created if vehicles, particularly buses and trucks, were allowed to use the unbuilt portion of West 242nd Street at Waldo Avenue as a driveway;

**WHEREAS,** West 242nd Street between Dash Place and Waldo Avenue is owned by the City of New York and under the purview of the NYC Department of Transportation;

WHEREAS, the developer of 55 Dash Place, also known as 3893 Waldo Avenue, Timber Equities, engaged a private contractor to pave the fifteen-foot width of the unbuilt street from the curb line of Waldo Avenue to rear property line of 55 Dash Place (1) without an easement, (2) without having secured permission from the NYC Department of Transportation to do so, and (3) without communicating their intent to other adjacent property owners;

**THEREFORE, BE IT RESOLVED,** Bronx Community Board 8 condemns and opposes the unilateral paving of the mapped, but unbuilt portion of West 242nd Street between Dash Place and Waldo Avenue adjacent to Brust Park until appropriate measures have been taken, in consultation with the NYC Department of Transportation and adjacent property owners, to ensure egress to the rear of 55 Dash Place is exclusively via a walkway - prohibiting vehicles - except where emergency access is mandated by the City of New York;

**BE IT FURTHER RESOLVED,** Bronx Community Board 8 calls on the New York City Department of Transportation to investigate and remedy the matter – including the installation of bollards or planters to protect the egress to 55 Dash Place from vehicular use - and report its finding and recommendations back to Bronx Community Board 8.
