Chair Ed Green called the meeting to order at 7:00pm

1. Introduction of Committee Members and Guests

Roll Call of Committee Members. Committee members introduced themselves.

Chair announced Scott Krompinger is no longer a member of the committee and had resigned from BXCB8 because of job related commitments. Scott was thanked for his service.

2. Approval of the February 20th, 2024, Public Safety Committee Minutes

A Board member's request to amend the minutes was discussed and the committee declined the requested amendment. The minutes were approved unanimously.

3. NYPD Report (*See attached NYPD CompStat Report) –

Lieutenant Dolan presented the NYPD CompStat report. Officers Amara and Sala were present. Issues discussed:

- 1 new hate crime reported (swastika graffiti). NYPD Hate Crime Task Force is the authority designated to determine what constitutes a hate crime. There is no categorized list of hate crimes used as criteria by the agency.
- Grand Larceny Auto increasing in the area.
- Delivery Driver robbed at gunpoint on block of 3400 Tibbett Avenue on February 23rd. Police investigation ongoing.

4. FDNY Report

Fire Battalion Chief Greg Lehr presented a statistical fire report for the district.

Fire at 36 Marble Hill Avenue on 3/11/24 caused by lithium-ion battery / E-Bike was discussed.

Some landlords are not allowing e-bikes to be stored in buildings and have signs posted on their buildings prohibiting them.

Committee discussed fire prevention measures and potential legislation to create safeguards for lithium-ion battery manufacturing, refurbishing, use and storage.

Committee will discuss legislation options with Elected Officials.

Committee will prepare a finalized budget list to present at next month's committee meeting.


