Report from the Mayor's Office

As of November 12, 2024, all properties with 1-9 residential units are required to use bins, 55 gallons or less, with secure lids for trash set out.

If you already use a bin with a secure lid that is 55 gallons or less for trash set out, you may continue to use it until June 2026. After that, you will need to switch to the Official NYC Bin.

Report from the NYPD 50th Precinct

Total of 118 crime complaints for the 28 day-period. Last year there were 133 complaints. No murders or rapes. Down in robberies – 6 vs. 12. Grand larcenies are also down – 40 vs. 64. Slight increase in felony assaults – 26 vs. 14. Most of them are domestic. Burglaries also slightly up – 13 vs. 11. No biased incidents to report for the period. Grand Larceny Autos (GLAs) are up – 33 vs. 32. In an effort to reduce vehicle thefts, the NYPD has been doing unannounced safety check points. Recommend to not leave any valuable items in the car.

Report from NYC Council Member (CM) Eric Dinowitz

Working with Council Member (CM) Pierina Sanchez to try to get funding for the Bailey Playground.

The Waldo Avenue Family Migrant Shelter has 91 rooms and 40 families currently living there. Over 100 kids live in the shelter. They are going to local schools with programs to support them. Individuals who are at the shelter and have e-bikes will park them in the rear rampway, and not inside the building or streets. The 24-hour contact information for

Committee Reports:

a) Law, Rules & Ethics -

Regarding the ADA (Americans with Disabilities Act) exemption from in-person attendance at meetings, the Law Rules & Ethics Committee recommends:

• the ADA and related State and City laws and regulations exist independently of the Open Meetings Law (OML), and there is no special requirement in the OML that any procedures be adopted by resolution;

- it is likely that decisions on ADA accommodation will be made on a case-by-case basis and standards will evolve naturally over time the types of justifications for ADA accommodation will be far more limited than the panoply of reasons for requests for Extraordinary Circumstances (EC) status;
- any decision on ADA accommodation will apply equally to Board meeting and committee meeting attendance – only one decision need be made for any given board member's request;
- decisions on ADA accommodations are ultimately the responsibility of the head of a public body, so as a practical matter, the Board Chairperson is the exclusive decisionmaker;
- although the Board Chairperson can delegate responsibility to screen requests for ADA accommodations, there are likely to be relatively few such requests, so that an additional administrative layer of this sort may not be warranted.

LAW, RULES & ETHICS COMMITTEE RESOLUTION: BRONX COMMUNITY BOARD 8 AWARDS

WHEREAS, Community Board 8 Bronx wishes to recognize community individuals and organizations that have extended themselves to help improve the quality of life in the community district 8 area; Therefore,

BE IT RESOLVED, that any Community Board 8 committee seeking to establish and bestow an award in the name of Community Board 8 must meet the following requirements before such award can be established and presented, and any additional criteria the committee may deem appropriate:

- A. Each standing committee or special committee offering a certificate or award is required to establish criteria, selection process, annual calendar (limit to one CB award in any month) and procedures for approval by the full Board.
- B. Limits on eligibility (e.g., no CB members, elected officials or persons who are salaried for their service, no self-nominations). In addition, there can be no direct or implied political connection, in the making of any award.
- C. A determination as to whether there should be a limit on the number of annual awardee(s).
- D. In addition to establishing award criteria, there should also be a procedure for establishing an awardee selection committee, soliciting candidates, identifying nominees, and a clear delineation of role of the Executive Committee and the full Board in granting the award.
- E. The criteria for establishing any award should be approved by a vote of the full Board at a monthly Community Board meeting; and

BE IT FURTHER RESOLVED, that any existing awards that do not meet these criteria must have their approval renewed by a vote of the Community Board.

b) <u>Aging –</u> The next meeting will be held on November 14th at the Board Office and an attorney will be speaking on elder law, wills and estates. M. Gibbs will be at an Older Adult Roundtable with NYC Mayor Adams on November 13th.

- c) <u>Budget</u> D. Gellman (On Zoom) gave the Budget Committee report. The FY26 Public Budget Hearing was conducted in October. Board members made minor changes to the budget priorities. There was no quorum for the October Full Board meeting to approve the priorities so the Chair called for a special meeting later in the month and a quorum was achieved and the priorities were approved. The priorities were entered into the NYC Mayor's Office of Management and Budget (OMB) system. The Fiscal Year 2027 process begins next month. Encourage Chairs to not wait until March or April, but rather initiate your committee discussions in December and the coming weeks. Many choose to use prior submissions as a starting point for discussion. Ask committee members to also come up with new ideas.

- **e)** Education, Libraries & Cultural Affairs The October 22nd meeting minutes were distributed. The SAPO application submitted by Rabbi Shemtov for the Chanuka Menorah Lighting on December 29, 2024 was approved by the Committee. Rabbi Shemtov did not attend and a resolution is not required for religious events, as per the SAPO office.
- **f) Environment & Sanitation –** D. Rowen presented the below resolution:

ENVIRONMENT & SANITATION COMMITTEE RESOLUTION

Resolution to Urge EPA to Adopt a Not Protective Determination in its Third Five-Year Review Concerning the Hudson River PCB Cleanup

WHEREAS, the Hudson River is an American Heritage River and the Hudson River Valley is a National Heritage Area, the health and beauty of the Hudson River is critical to the economic vitality of the communities surrounding it; and

WHEREAS, Bronx Community Board 8's district borders the lower-Hudson River Valley; and

WHEREAS, Bronx Community Board 8 has been a long time advocate for improved river access (including for the extension of the Hudson River Greenway) as well as cleaner water for all residents; and

WHEREAS, for 30 years, from 1947-1977, General Electric ("GE") dumped polychlorinated biphenyls ("PCBs") into the Hudson River from two capacitor manufacturing plants located in the towns of Fort Edward and Hudson Falls, N.Y.; and

WHEREAS, as a result of GE's PCB contamination, the U.S. Environmental Protection Agency ("EPA") designated a 200-mile stretch of the Hudson River from Fort Edward to New York Harbor as a Superfund Site in 1984; and

WHEREAS, PCBs are man-made, bioaccumulative, persistent organic pollutants that have been linked to a wide variety of adverse health effects, including, among others: cancers,

liver, and kidney disorders; reduced birth weight, conception rates, and live birth rates; persistent and significant deficits in neurological development, including visual recognition, short-term memory and learning; and developmental problems due to interference with thyroid hormone levels; and

WHEREAS, PCBs discharged by GE are still found at dangerous levels throughout the Hudson River ecosystem and as far south as New York Harbor: in soils and sediments within the river and the surrounding floodplains; in the living tissues of wildlife, from low-level organisms to larger animals such as birds and fish; and, periodically, suspended in the river itself or in the air; and

WHEREAS, in 2002 EPA selected a two-part cleanup plan to address in-river sediments in the Upper Hudson River, a 40-mile stretch of the Hudson River between Fort Edward and the Federal Dam at Troy, which called for targeted dredging of PCB-contaminated sediment from the river bottom, followed by an extended period of natural recovery; and

WHEREAS, the selected cleanup remedy was designed to reduce the dangerous health risks to humans and wildlife living in and near the Hudson River PCBs Superfund Site in an expedited time frame and reestablish the ecological and economic health of the Hudson River; and

WHEREAS, EPA's original cleanup plan also focused on minimizing the long-term downstream transport of PCBs to the Lower Hudson River, a 160-mile stretch of the Hudson River from the Federal Dam at Troy to New York Harbor; and

WHEREAS, with the completion of dredging in 2015, the cleanup has transitioned from the dredging phase to the natural recovery phase; and

WHEREAS, federal Superfund law requires EPA to conduct a study every five years to evaluate the implementation and performance of the remedy to determine if the remedy is protective of human health and the environment; and

WHEREAS, on July 10, 2024, EPA released its draft third five-year review concluding that EPA needs more years of fish data to determine if the cleanup is meeting the expectations of the original cleanup plan; and

WHEREAS, EPA's draft third five-year review report does not adequately address scientific data and analysis that show that there has been little improvement in fish and sediment PCB concentrations since the completion of dredging; and

WHEREAS, PCB concentrations in Upper Hudson River fish and sediment are not declining as anticipated by EPA to reach key remediation targets and adequately minimize the downstream transport of PCBs to the Lower Hudson River; and

WHEREAS, the continued presence of PCBs in the Hudson River has significantly diminished economic activity and recreational use and enjoyment of the river; and

WHEREAS, the understanding of the relationship between how much PCB was left behind in the sediments and the rates of recovery in sediment and fish needs to be updated to determine if further remedial work is necessary to protect human and environmental health; and

WHEREAS, the data available supports the conclusion that the selected remedy is not protective of human health and the environment. The human health and ecological risks are well in excess of EPA's acceptable risk ranges, and will not be in the acceptable range for the foreseeable future; and

NOW THEREFORE BE IT RESOLVED, that Bronx Community Board 8, hereby urges the EPA to adopt a "not protective" determination" in the third five-year review and acknowledge the failure of the Upper Hudson River remedy to meet the goals and objectives of the cleanup.

BE IT FURTHER RESOLVED, that the EPA must begin the process of assessing additional remedial actions to protect the environment and our vulnerable communities along the Hudson River, who will otherwise continue to be exposed to toxic levels of PCBs for generations to come.

- i) <u>Land Use</u> Both items (building of townhouses at 3111 Henry Hudson Pkwy and the construction of a housing complex in Van Cortlandt Village) in the Land Use Committee Agenda in November were tabled to the next Land Use Committee meeting to give more time for the community to have discussions with the applicants. The Land Use Subcommittee on the Van Cortlandt Village Construction will also meet on November 25th to discuss further.

Report from NYC Council Member (CM) Pierina Sanchez

Introduced legislation to authorize the J-51 tax incentive. The J-51 tax incentive is an as-of-right tax exemption and abatement for residential rehabilitation or conversion to multiple dwellings.

Had a hearing with the NYC Council Housing Committee on illegal lockouts and tenant safety. A number of bills were heard there.

Next week, there is an important hearing on deed theft. If you are interested on that topic, please join us for testimony.

Introduced a legislation called the Housing Rescue and Resident Protection Act: a transformative set of reforms to the Third-Party Transfer (TPT) program, originally established in 1996 to address the challenges posed by buildings in financial and physical distress. The new legislation aims to protect homeownership and low-income communities while holding landlords and negligent owners accountable and secure safe living conditions for residents.

Met with Chairperson J. Reyes and District Manager F. Kule Rubin and went over the budget priorities and look forward to supporting those asks, especially the ones that fall in Council District 14.
